- 4) Financial Proposal ONE (1) Original and 2 copies

Bid Validity: Proposals should be valid for at 90 Calendar days from the bid closing date.

**Bid Opening:** Technical Proposals only will be opened immediately after the bid closing hours, at 15:00 hours in the presence of bidders or bidders' representatives who choose to attend, in the Meeting room of Administration and Human Resources Management. Late bids will be rejected and returned unopened to bidders.

Bid Submission modalities and submission deadline: This is a two envelope bidding. Bidders should ensure that the Technical and Financial proposals are enclosed in **TWO separate envelopes** sealed and both should be enclosed in one Outer envelope clearly indicating the title and Procurement number. Proposals must be submitted no later than 9<sup>th</sup> November 2018 at 15:00hrs
