TERMS OF REFERENCE TO REVIEW THE MALABO CONVENTION ON CYBERSECURITY AND PERSONAL DATA PROTECTION AND RECOMMEND POSSIBLE AMENDMENTS TO ARTICLES

Procurement Reference Number: AUC/IED/C/006

Introduction

This document outlines the terms of reference for the review of the Malabo convention on Cybersecurity and Personal Data Protection (The Convention) and recommendations for amendments to outmoded Articles and provisions.

The convention was drafted following the request of the Extra-Ordinary Conference of African Union Ministers in charge of Communication and Information Technologies held in 2009 to develop jointly with the United Nations Economic Commission for Africa, a convention on cyber legislation based on the Continent's needs and which adheres to the legal and regulatory requirements on electronic transactions, cybersecurity, and personal data protection.

The Convention¹, that aims at promoting effective harmonization of African legal instruments in the area of electronic transactions, personal data protection and cybersecurity, was adopted in June 2014 by the AU Heads of State and Government. It calls upon AU Member States to recognise the need to protect critical infrastructure, personal data and to encourage free flow of information through a unified regulatory framework. So far only 10² instruments of ratification have been deposited. The Convention is yet to enter into force as per Article 36 of the Convention by reason of inadequate ratification from the required fifteen (15) African States.

In order to expedite the ratification of the Convention and its entry into force, the African Union Cybersecurity Experts Group (AUCSEG) carried out in 2021 a comprehensive review of the Malabo Convention with a view to recommend elements of the Malabo Convention to be considered for revisions and amendment. A taskforce meeting was also organized in 2021 to get more feedback on the recommendations. Among others, the main recommendation is to carry out further detailed analysis of the articles and come-up with concrete amended texts as well as suggesting further actions.

Aim and Objectives

The aim of the review of the Articles of the **Malabo convention on Cybersecurity and Personal Data Protection is to** accelerate the process for securing the required number of instruments of ratification to occasion the entry into force; document the gaps in the Convention to responds to latest global standards and norms in cyberspace and the ever increasing cyber challenges in Africa and forward recommendations on articles to be amended, deleted, and/or added upon ratification of the Convention and its entry into force.

Scope of work

- 1. Undertake a detailed analysis of the articles of the Convention taking into account the review report findings and the proposed recommendations of the review process conducted in 2021.
- 2. Identify and document the potential gaps in the Convention
- 3. Suggest the potential priority Articles for amendments
- 4. Prepare the appropriate and formal legal texts for the amended Articles
- 5. Prescribe suggested actions in support to the ratification of the Convention and its entry into force

In line with the above the consultant shall:

- 1. Attend a kick off meeting of the study to be held upon awarding of the contract;
- 2. Participate in internal meetings with AUC if required;
- 3. Present the document to the Taskforce members and incorporate their comments and contributions.
- 4. Service the validation workshop of the draft report;
- 5. Write a final version of the report.

Expected Outcomes and Deliverables

- 1. Detail analysis on the articles of the Convention
- 2. Identification of the gaps and priority areas
- 3. List of priority Articles for Amendments and their revised legal wordings
- 4. A compiled report on possible amendments of the Articles of the Convention
- 5. List of suggested actions in support of the ratification process

Duration of Assignment

The duration of the assignment is sixty (60) days spread between a tentative period, June to September 2022
