The Africa Union has received financing from the Member State toward the cost of enhancing National Public Health Institutes (NPHIs) Regional Centres of Excellence (CoEs) capacity and intends to apply part of the proceeds toward payments under the contract for the supply, delivery and installation of Data Centre Equipment.

The African Centres for Disease Control and Prevention (Africa CDC) now invites sealed Bids from eligible Bidders for supply, delivery and installation of data center equipment in nine (9) lots, as listed below, details provided in the bidding document, within 90 calendar days after contract signing date.
