The Africa Union the Recipient has received financing from the African Development Bank hereinafter called the Bank toward the cost of the Africa CDC Covid-19 Response Project and intends to apply part of the proceeds toward payments under the contract for Procurement of Laboratories consumable and equipment to Support the Mpox Response in Member State.
2. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the Bank's Disbursement Guidelines and procedures for Investment Project Financing, except for those payments, which the contract provides to be made through letter of credit.
3. The Africa CDC now invites sealed Bids from eligible Bidders for Procurement of Laboratories consumable and equipment to Support the Mpox Response in Member State.
