

## DECISION ON THE REPORTS OF THE SUB-COMMITTEES OF THE PERMANENT REPRESENTATIVES' COMMITTEE (PRC)

### The Executive Council,

- **1. TAKES NOTE** of the PRC recommendations on the reports of its Sub-Committees, taking into account observations made by Member States.
- I. ON THE SUB-COMMITTEE ON AUDIT MATTERS Doc: EX.CL/1343(XLI)

### The Executive Council,

- 2. TAKES NOTE of the report of the PRC Sub-Committee on Audit Matters and ENDORSES the relevant recommendations;
- 3. COMMENDS the Office of Internal Oversight (OIO) for the extensive work and good performance in providing oversight on audit matters across the Union and REQUESTS the OIO to continue strengthening administrative and financial governance as well as the culture of accountability within the African Union.

## A. TERMS OF REFERENCE FOR THE SUBCOMMITTEE ON AUDIT

- 4. RECALLS Decision EX.CL/Dec.752(XXII) which approved the terms of reference on the mandate and work of the PRC Sub-Committee on Audit Matters and COMMENDS the Sub-Committee for assessing its own work using these terms of reference;
- 5. ENCOURAGES the Sub-Committee on Audit Matters to review its Terms of Reference in line with the additional mandate given on its work in line with the Revised African Union Financial Rules;
- **ENCOURAGES** the Chairperson of the Sub-Committee to communicate with the respective Regional Deans to replace any members when their seats fall vacant in line with the requirements of the Terms of Reference of the Sub-Committee;
- 7. **DIRECTS** the Commission to assist the Sub-Committee in carrying out its mandate as per its Terms of Reference, AU Financial Rules and directives given by the Executive Council decisions;
- **8. RECALLS** Decision EX.CL/Dec.1097(XXXVII), paragraph 70, and accordingly **REQUESTS** the Commission to organize a retreat for the members of the Sub-Committee in October 2022 to provide the necessary capacity building needs for effectively carry out their mandate.

## B. BRIEFING ON THE FINANCIAL RULES (2022) AND THE STAFF REGULATIONS AND RULES (2010)

- **9. TAKES NOTE** of the presentations and **EXPRESSES** concern about the delays in finalizing the review of the Staff Regulations and Rules (SRR);
- 10. FURTHER EXPRESSES CONCERNS on various articles in the SRR which have implementation challenges with high risks to the Union and CALLS UPON the Commission to urgently complete the review exercise, as envisaged in Decision EX.CL/Dec.1144(XL), of the proposals relating to certain entitlements in the draft revised SRR;
- **11. INSTRUCTS** the Commission, AU Organs and Institutions to adhere to the AU rules and regulations;
- 12. REITERATES that disciplinary and punitive actions should be taken on staff and other officials with negative audit findings as a result of violating the rules, whereas those who left the Union with unsettled liabilities should be pursued to the extent of involving the Member States and other similar sister international organizations where they may have gone so as to recover Union's resources in line with Decision EX.CL/Dec.1126(XXXIX), paragraphs 56(iii), 58 and 59;
- **13. URGES** the Commission to make quarterly staff quota reports availed to Member States and also make job publications known to them on time;
- 14. FURTHER URGES Member States to pay their assessed contributions on time to ensure adequate funding of the Union's annual budgets as required by the AU Financial Rules.

## C. OFFICE OF INTERNAL OVERSIGHT (OIO) ACTIVITY REPORT FOR THE YEAR 2021

- **15. TAKES NOTE** of the report and **COMMENDS** the OIO for producing a comprehensive annual performance report on its operations;
- **16. DIRECTS** the OIO to include all relevant information on the key audit findings on internal control weaknesses noted each year in the utilization of the Union's resources;
- 17. **DIRECTS** the OIO to technically assist in capacitating Commission's departments to perform self-auditing through their own staff under the current structure.
  - D. GOVERNANCE, RISK MANAGEMENT AND INTERNAL CONTROLS

**18. REQUESTS** the PRC Sub-Committee on Headquarters and Host Agreements to tackle the outstanding issues regarding audit findings related to non-existence/expiry of host agreements and unclaimed VAT issues;

- **19. URGES** the Commission to finalize and present the treasury and investment policy to ensure that Union's resources are well managed;
- 20. NOTES WITH GRAVE CONCERN various errors and delays in bank reconciliations and DIRECTS the Commission, through the Directorate of Finance, to put in place bank reconciliation policy to ensure that proper and timely reconciliations are made, and FURTHER DIRECTS the Commission to apply the appropriate disciplinary measures on staff members who fail to carry out bank reconciliations properly;
- 21. ALSO NOTES WITH CONCERN the huge number of unused flight tickets and the amounts incurred therein and **DIRECTS** the Commission to develop a comprehensive policy to address this issue and report to the Executive Council in February 2023;
- 22. EXPRESSES concern about the long outstanding advance payments to vendors and weakness in the procurement to process payments and cases of double payments and therefore REQUESTS the Board of External Auditors to carry out a comprehensive audit on procurement policies across the Union, payment processes, and all outstanding advance payments to vendors;
- 23. TAKES NOTE of the recurrent nature of the findings of the non-recovery of salary and travel advance payments to staff as well as imprest and loans, and the questionable nature of the entire process and the eligibility of staff members to be granted those benefits, and REQUESTS the Board of External Auditors to carry out an investigation on the status of all non-recovered amounts and the soundness of the processes for further disciplinary measures as necessary.

## E. MATRIX ON IMPLEMENTATION OF EXECUTIVE COUNCIL DECISIONS ON AUDIT MATTERS

- 24. TAKES NOTE of the report and COMMENDS the Sub-Committee on Audit Matters for following up the implementation of the Executive Council decisions emanating from its work;
- 25. **EXPRESSES** serious concern about the delay in the implementation of audit decisions as well as the late responses from Commission and other AU Organs and **DIRECTS** the Commission and other AU Organs to provide a quarterly update on the implementation of Executive Council decisions related to audit matters and the challenges they face in this regard;

**26. DIRECTS** the Commission and other AU Organs to implement all Executive Council decisions on time and in line with the timelines thereof.

F. OFFICE OF INTERNAL OVERSIGHT (OIO) REPORT ON BUDGET PERFORMANCE FOR THE YEAR 2021 FOR AU ORGANS (AfCHPR, AUABC, AfCFTA, AUDA-NEPAD, ECOSOCC, PAP, ACHPR, APRM, CDC AND AUC)

- 27. TAKES NOTE of the reports and DIRECTS all AU Organs to implement fully the recommendations contained in their individual internal audit reports on budget performance for the year 2021 and comments from Member States;
- 28. EXPRESSES serious concerns on the low rate of implementation of programmes in most AU Organs and CALLS UPON all managers to ensure that implementation of programmes is enhanced;
- 29. RECALLS Decision EX.CL/Dec.1143(XL), paragraph 18(iii), and DIRECTS the Commission and other AU Organs to plan realistically to avoid low implementation rate and reduction of their respective budget ceilings as a result and REITERATES that a minimum rate of implementation threshold should be set up and submitted for consideration by the Sub-Committee on General Supervision and Coordination on Budgetary, Financial and Administrative Matters, so as to prevent departments from making high budget proposals and align budget proposals based on the available capacity of human resources;
- 30. REQUESTS the Commission to harmonize the internal audit reports on budget performance among all AU Organs and include adequately all relevant information when reporting on budget performance;
- 31. RECALLS Decisions EX.CL/Dec.815(XXX); EX.CL/Dec.1031(XXXIV) paragraph 11; EX.CL/Dec.1057(XXXV) paragraph 39 (b) and (h); EX.CL/Dec.1069(XXXV) paragraphs 10, 11 and 12; EX.CL/Dec.1071(XXXV) paragraph 9; EX.CL/Dec.1073(XXXVI) paragraph 40; EX.CL/Dec.1097(XXXVII) paragraph 18, and EX.CL/Dec.1143(XL) paragraph 18, and REITERATES that all departments within the Commission and other AU Organs that do not submit their reports in AMERT as required should not have their budget proposals considered for approval;
- **32. RECALLS** Decision EX.CL/Dec.1073(XXXVI), paragraph 66(iii), and EX.CL/Dec.1057(XXXV), paragraph 39(b), that directed the release and allocation of budget to be in proportion with the performance in line with the AU Golden Rules on Budgeting and an average budget execution rate of the previous three years a s well as implementation rate of audit recommendations;
- **33. URGES** the Commission and other AU Organs to ensure that the budget execution reports reflect the impact of the programmes:

**34. FURTHER URGES** the Commission to put an effective strategy to engage Partners with low funding levels as compared to the pledges made so as to avoid budgets with funding gaps in line with Golden Rule Number 2;

- **35. RECALLS** Decision EX.CL/Dec.1143(XL), paragraph 18(iv), and **URGES** the Commission to improve the AMERT system and **DIRECTS** all AU Organs to start using the AMERT system for effective planning, monitoring, evaluation and reporting of projects performance and avoid using manual systems;
- **36. FURTHER INSTRUCTS** the Union management to tackle issues of reporting comprehensively to address concerns of both Member States and partners and to submit a report in this regard to the Sub-Committee on Audit Matters by November 2022;
- 37. **EXPRESSES GRAVE CONCERNS** on the challenges of staffing among all AU Organs and Departments of the Commission and their impact on implementation rates and **DIRECTS** the Commission to develop a comprehensive recruitment strategy to resolve this problem;
- 38. ALSO WELCOMES the trilateral informal consultations by Members of the Sub-Committee, Commission and partners to address audit related matters and ENCOURAGES the continued informal engagements with the partners.
  - G. THE INCEPTION REPORT ON FORENSIC AND PERFORMANCE AUDIT OF THE OTHER AU ORGANS
- 39. TAKES NOTE of the report and COMMENDS the Sub-Committee on Audit Matters for following up the implementation of the Executive Council decision on forensic and performance audit of other AU Organs;
- **40. EXPRESSES** concerns on the delays in the procurement process and selection of the firm and **CONGRATULATES** Lochan & Co. for winning the bid;
- 41. **EXPRESSES** concerns on the challenges faced by the audit firm and **DIRECTS** all concerned AU Organs to cooperate with the audit firm, in particular on the provision of documents;
  - H. MATRIX ON IMPLEMENTATION OF AUDIT RECOMMENDATIONS AS AT 31 DECEMBER 2021
- **42. TAKES NOTE** of the report and **COMMENDS** various managers for the efforts made in the implementation of previous internal audit recommendations;
- **43. URGES** the OIO to continue with the periodic follow-up on the implementation of audit recommendations accordingly:

**44. INSTRUCTS** the Departments of the Commission and other AU Organs which have low implementation rates of audit recommendations to implement them without further delay, and to update the Sub-Committee on challenges faced in implementation in order to address them on a timely manner;

- **45. DIRECTS** that the implementation status report should highlight the significance of the Executive Council decisions on audit matters in future updates;
- **46. FURTHER DIRECTS** the Commission to consolidate all types of audit recommendations (internal/external/forensic) in one matrix using the Matrix of Audit decisions as a base.

I. OIO CERTIFICATION REPORTS ON RESERVE FUND AND OTHER FUNDS (MAINTENANCE, WORKING CAPITAL, PEACE FUND AND ADMINISTRATIVE COST FUND)

- 47. TAKES NOTE of the reports and CALLS UPON the Commission to put in place effective systems in the prudent management of the Reserve, AU Maintenance Fund, Working Capital Fund, Peace Fund and Administration Cost Fund in line with AU Financial Rules, and further DIRECTS as follows:
  - regular monthly reviews and reconciliations should be made on the fund accounts to ensure adherence to the AU Financial Rules and also to ensure effective management of the funds;
  - ii. the Executive Council decisions made on the creation and maintenance of special funds should be followed in the management of the funds.
  - J. PROGESS REPORT OF THE CHAIRPERSON OF THE AU COMMISSION (AUC) ON THE IMPLEMENTATION OF RECOMMENDATIONS OF THE PWC FORENSIC AND PERFORMANCE AUDIT ON AUC
- 48. TAKES NOTE of the report and COMMENDS the Commission's leadership for the comprehensive report submitted on further actions taken in the implementation of the recommendations by the PWC's forensic audit and the measures taken to enhance the work of Internal Accountability Committee (IAC);
- **49. INSTRUCTS** the Chairperson of the Commission to enhance the implementation of the audit recommendations contained in the report and explore measures to shorten the length of time taken for the examination of each case in the report within the provisions of the SRR;
- **50. RECALLS** Decisions EX.CL/Dec.1126(XXXIX) and EX.CL/Dec.1031(XXXIV), and **DIRECTS** the Commission to ensure that recoveries are made on all cases

that had financial losses identified in the PWC forensic audit report and other previous cases in a timely manner;

- **51. ALSO DIRECTS** the Commission to reduce the 10 years' recovery period given to the staff who owed the Union an amount of US\$82,702.00:
- 52. RECALLS Decision EX.CL/Dec.1107(XXXVIII), paragraph 76(c), which requested "to carry out a comprehensive audit to cover the staff files that were not covered by PWC since the sample size for the forensic audit covered only 112 files, and also to review the period 2019 to 2020 not covered by the PwC on all audit required areas" and TAKES NOTE of the objectivity affecting the OIO to review its own staff personnel files and REQUESTS the Board of External Auditors to carry out this investigation in line with Article 89(e) of the AU Financial Rules;
- 53. DIRECTS the Commission to impose strong sanctions on staff who violate the rules in line with the offense involved to reflect the misconduct committed, strengthen the on boarding processes and develop ethical and accountability frameworks and training programs to develop a culture of integrity and honesty within the Commission and other AU Organs;
- **54. RECALLS** Decisions EX.CL/Dec.1126(XXXIX)(vi), EX.CL/Dec1057(XXXV), paragraph 32(vii), and EX.CL/Dec.1143(XL), paragraph 18(iv), and **INSTRUCTS** the Commission to optimize the use of SAP for effective budgetary control, financial management and reporting in order to ensure value for money;
- 55. ALSO RECALLS Decision EX.CL/Dec.1126(XXXIX), paragraph 56(v), and INSTRUCTS the Commission to re-enforce the effectiveness of internal control systems by strengthening and prioritizing the recruitment for the key offices and directorates in charge of these controls including CDCP, ODG, OLC, HRM, OSS and OIO;
- **FURTHER RECALLS** Decisions EX.CL/Dec.1057(XXXV), on the Transitional Plan, and EX.CL/Dec.1143(XL), paragraph 22, and **DIRECTS** the Commission to develop a strategy on how to speed up recruitments in the new structure and submit it for consideration of relevant PRC Sub-Committees by October 2022:
- 57. RECALLS IN ADDITION Decisions EX.CL/Dec.1031(XXXIV), paragraph 26, and EX.CL/Dec.1097(XXXVII) and DIRECTS the Commission to expedite the process of reviewing the SRR and ensure that they are adopted in the February 2023 summit. The revision of the SRR should also tackle the issues related to accountability and recovery of misappropriated funds by all staff categories and elected officials;
- **58. ALSO RECALLS** Decision EX.CL/Dec.1107(XXXVIII), paragraph 79, and **DIRECTS** the Commission to work closely with the forensic audit firm appointed

to audit other AU Organs to avoid the challenges faced with the outcomes of PWC report;

- **59. FURTHER RECALLS** Decision EX.CL/Dec.1126(XXXIX), paragraph 56(iv), and **DIRECTS** the Commission to ensure full implementation of the outstanding recommendations and submit a full and comprehensive implementation report as at 31 December 2022 which is the deadline.
- II. ON THE SUB-COMMITTEE ON MULTILATERAL COOPERATION Doc. EX.CL/1344(XLI)
  - A. DEVELOPMENT OF THE AU PARTNERSHIPS STRATEGY AND POLICY FRAMEWORK
- **NOTES WITH CONCERN** the delays in the finalization of the Draft Partnerships Strategy and Policy Framework;
- 61. REQUESTS the PRC in close collaboration with the Commission to finalize the Draft Partnerships Strategy and Policy Framework for consideration by the Executive Council in February 2023.
  - B. THE AU-EU PARTNERSHIP
- **62. COMMENDS** the European Union and the Government and people of Belgium for the successful hosting of the 6<sup>th</sup> AU–EU Summit on 17–18 February 2022, in Brussels, Belgium;
- **63. RECOMMENDS** to the Assembly to endorse the Declaration of the 6<sup>th</sup> AU–EU Summit;
- **REQUESTS** the PRC, in close collaboration with the Commission and the European Union to follow-up on the implementation of the Commitments made during the 6<sup>th</sup> AU-EU Summit and in particular to operationalize the AU-EU Partnership Ministerial Follow-up Committee, adopted during the 2<sup>nd</sup> AU-EU Ministerial Meeting held in Kigali, on 25-26 October 2021, in line with its Decision EX.CL/Dec.1143(XL).

#### C. AFRICA-ARAB PARTNERSHIP

**65. TAKES NOTE** of the proposal by the League of Arab States (LAS) and the Kingdom of Saudi Arabia (Host country of the 5<sup>th</sup> Africa-Arab Summit) to hold the 5<sup>th</sup> Africa-Arab Summit either during the first semester of 2023 or during the last quarter of 2023;

66. **REQUESTS** the PRC, in close collaboration with the Commission, the General Secretariat of the League of Arab States and the host country of the 5<sup>th</sup> Africa—Arab Summit, the Kingdom of Saudi Arabia, to agree on the exact dates for the holding of the 5<sup>th</sup> Africa—Arab Summit and its statutory preparatory Meetings in Riyadh, Saudi Arabia, taking into consideration the above-mentioned proposals and subject to the improvement in the public health conditions caused by the COVID-19 pandemic.

- D. TOKYO INTERNATIONAL CONFERENCE ON AFRICAN DEVELOPMENT (TICAD)
- **67. TAKES NOTE** of the consultations made during the TICAD Ministerial Meeting, which was held on 26–27 March 2022, through a complete virtual process;
- **REQUESTS** the PRC, in collaboration with the Commission, the Republic of Tunisia (host country) and Japan, to fast track preparations for the TICAD 8 Summit, foster inclusiveness in accordance with the relevant AU decisions and to make every effort to ensure a successful TICAD 8 Summit;
- 69. ALSO REQUESTS the PRC, in close collaboration with the Commission and the African Diplomatic Corps in Tokyo, to take the lead in consolidating the contributions from AU Member States with regard to the Draft TICAD 8 Summit Declaration;
- 70. REITERATES Decision Assembly/AU/Dec.762(XXXIII), which "REAFFIRMS the right of all AU Member States to participate in Statutory Meetings, related to partnerships between the African Union/African Continent and another Continent or Regional Organization" and "DECIDES that African Union/African Continent shall be represented at the Statutory Meetings of partnership between the African Union/African Continent and a partner country by the Members of the Bureau of the Assembly of the Union, the Chairpersons of Regional Economic Communities (RECs), the Chairperson of the Heads of State and Government Orientation Committee (HSGOC) of AUDA-NEPAD and the Chairperson of the AU Commission".

#### E. AFRICA-KOREA PARTNERSHIP

- **71. COMMENDS** the Government and people of the Republic of Korea for the successful hosting of the 5<sup>th</sup> Korea-Africa Forum on 3 March 2022, in Seoul, Republic of Korea;
- **72. ENDORSES** the 5<sup>th</sup> Korea–Africa Forum Declaration as well as the Korea–Africa Forum Framework of Cooperation 2022–2026;

**73. REQUESTS** the PRC, in close collaboration with the Commission and the Republic of Korea to follow-up on the implementation of the commitments made during the 5<sup>th</sup> Korea-Africa Forum through the Annual Policy Consultation Meeting.

- 74. TAKES NOTE of the reports of the PRC and Joint Sitting of its Sub-Committee on General Supervision and Coordination on Budgetary, Financial and Administrative Matters, Sub-Committee of Programs and Conferences and the F15's Technical Experts;
- **75. APPROVES** a total AU budget for 2023 of an amount of **US\$654,878,933.00** broken down as follows:
  - a) The Regular budget of **US\$402,728,529.00** is broken down as follows:
    - i) Operating budget of US\$163,697,256.00 to be funded as follows:
      - US\$160,608,255.00 (98%) assessed on Member States;
      - US\$3,089,000.00 (2%) from Maintenance Fund;
    - ii) Program Budget of US\$239,031,273.00 to be financed as follows:
      - US\$44,391,744.00 (18.6%) assessed on Member States;
      - US\$811,000.00 (0.3%) from the Maintenance Fund;
      - US\$10,000,000.00 (4.2%) from the Administrative Fund;
      - and US\$183,828,529.00 (76.9%) to come from International Partners, out of which US\$19,418,162.00 is Technical Assistance;
  - b) Peace Support Operations with a total budget of **US\$252,150,404.00** fully funded by international partners;
  - c) Overall, the Union budget for 2023 will be financed as follows:
    - i) US\$205,000,000.00 (31.3%) to be assessed on Member States;

- **78. DECIDES** that, in light of the effects of COVID-19, the Russia-Ukraine crisis and the food insecurity on the continent, the 2023 budget continues to be an austerity budget and its provisions are prioritized and rationalized;
- 79. RECALLS Decisions EX.CL/Dec.813(XXV), and EX.CL/Dec.899(XXVIII)Rev.2, and REITERATES the need to limit reliance on partner funding in accordance with all relevant decisions of the Policy Organs, in line with Assembly/AU/Dec.578(XXV);
- **80. CALLS UPON** the Africa Centres for Disease Control and Prevention (Africa CDC) to apply the rules and regulations of the Union on all of its operations, including on matters of expediting the recruitment of its staff;
- 81. DECIDES to put on hold the implementation of the 0.5% fund for the Africa CDC from the annual operational budget until such a time the statute and structure of the Africa CDC are adopted;
- 82. DIRECTS the Commission to set up a working group comprising of Member States, F15, AUDA-NEPAD and the Commission's Directorate of Finance, Office of Strategic Planning and Delivery (OSPD), Bureau of the Deputy Chairperson and Office of the Legal Counsel, in close collaboration with the Office of the Director General, to address overlaps and duplications among AU Organs, Agencies and Departments of the Union;
- 83. CALLS UPON the Commission, through the Office of the Director General, to hold a retreat involving AU Organs and its Departments prior to organizing the budget retreat of the Joint Sitting of Sub-Committees of GSCBFAM, Programs and Conferences and F15 technical experts, in order to discuss the issues of duplication of programs and activities amongst its departments and other AU Organs;

- **104. REQUESTS** the Commission to retain PAPS staff in critical **positions** under the JFA, including at Liaison Offices (LOs), and this should be done in keeping with the quota system and pending the lifting of the moratorium on recruitment to warrant new recruitment;
- **105. FURTHER REQUESTS** the Commission to develop an exit strategy for JFA staff members of the liaison offices who have exhausted their limit for the contract renewal process while they continue to hold critical positions. This exit strategy should be subject to the quota available for each Member State. The strategy should be presented to the Joint Sitting of GSCBFAM and the F15 technical experts latest by September 2022.

- 115. APPROVES the reduction of the Gap Cap, from nine (9) to six (6) months during the implementation period of the transition plan to support the intensive recruitment drive, notwithstanding within grade quota restrictions;
- **116. DIRECTS** the Commission to ensure that applicants from underrepresented Member States are prioritised without prejudice to the principle of merit-based recruitment, transparency and fairness;

- **128. COMMENDS** the PRC Sub-Committee on Human Rights, Democracy and Governance and the Commission for the progress made towards the finalization of the AU Strategic Action Plan for the Promotion and Protection of Human and Peoples' Rights in Africa;
- **129. TAKES** note of the Draft Strategic Action Plan and **REQUESTS** the Commission to finalize and submit it to the Executive Council in February 2023 for consideration and adoption;
- **ALSO REQUESTS** the Commission and the Sub-Committee to finalize and submit the AU guidelines on elections during Covid-19 and other public health emergencies and the African Charter on Democracy, Elections and Governance (ACDEG) School Curriculum Strategy in line with Decision EX.CL/Dec.1143(XL), paragraph 75, to the Executive Council in February 2023 for consideration and adoption.

REQUESTS the Commission to coordinate the submission of the consolidated African Position Paper to the African Group of Negotiators (AGN) for onward transmission to the African Ministerial Conference on the Environment (AMCEN) and the Committee of African Heads of State and Government on Climate Change (CAHOSCC) for endorsement;
- 33. ALSO REQUESTS the Commission, in collaboration with AFREC, AfDB and UNECA, to work with the Member States to develop national energy transition masterplans and resource mobilization strategies for Member States and RECs, and strategies to accelerate implementation;
- **34. FURTHER REQUESTS** the Commission, AUDA-NEPAD, AfDB, and UNECA to develop and implement a continental framework and programme on technology transfer that will enable the Member States to access, manufacture, adopt, and adapt energy access and transition technologies to their local and national needs:
- 35. REQUESTS Member States to accelerate efforts towards facilitating energy access and transition through the allocation and mobilization of domestic financing, developing carbon markets, the creation of a conducive environment for private sector participation and increased commitment to regional integration of energy markets;
- **ALSO REQUESTS** Member States to define decarbonization targets through the Nationally Determined Contributions (NDCs) and accelerate efforts towards decarbonizing and improving energy efficiency in key sectors including transport, electricity, and industrial sectors; subject to receiving the financing pledged at COP26;
- 37. FURTHER REQUESTS the Commission and its continental and regional partners to accelerate the implementation of key initiatives including the Continental Power Systems Masterplan (CMP), Programme for Infrastructure Development in Africa (PIDA-PAP2), the Africa Renewable Energy Initiative (AREI), the African Single Electricity Market (AfSEM) and the African Energy Transition Programme (AETP);

**38. REQUESTS** the Commission in collaboration with continental and regional institutions to develop a continental programme on green hydrogen to create sustainable and cost-effective domestic and international markets and develop appropriate financing, policy and regulatory frameworks and partnerships with other world regions to develop the technologies;

- 39. ALSO REQUESTS the African Commission on Nuclear Energy (AFCONE) and African Regional Cooperative Agreement for Research, Development and Training related to Nuclear Science and Technology (AFRA) to accelerate the implementation of appropriate frameworks to utilize nuclear energy and continue to foster cooperation at the regional, continental and global levels to mobilize financing, acquire technologies, enhance skills and expertise, and address the associated risks;
- 40. UNDERSCORES and COMMENDS the initiative for energy access and just transition in Africa proposed by the Arab Republic of Egypt, SUPPORTS the preparation for COP27 and CALLS ON the Arab Republic of Egypt to champion the African common position going forward;
- 41. CALLS ON partners, stakeholders and potential public and private investors to support Africa's common position for energy access and just transition and to help develop technical and financial instruments and packages to fast-track African's right to universal access to affordable and reliable electricity and clean cooking as well as clean fuel and transport.

## B. Impacts of the Russia-Ukraine Crisis on the Infrastructure and Energy Sectors in Africa:

REQUESTS the Commission, in collaboration with specialized Pan-African institutions and all relevant stakeholders, to continue monitoring the evolving situation of the Russia-Ukraine crisis and its impact on infrastructure and energy sectors and advise Member States on appropriate mitigation measures and intensify the development of data systems on energy consumption and behaviour in the Continent;
- 43. ALSO REQUESTS the Commission in collaboration with specialized Pan-African institutions, to coordinate the implementation of the following recommendations to mitigate the impacts of the Russia-Ukraine crisis and to increase and improve Africa's resilience in the face of future shocks/crises:
  - i) develop an African Energy Security and Financing Plan that promotes intra-African trade and increased African oil production; refining African crude oil in African refineries and pan-African storage and distribution infrastructure (ports, terminals, maritime transport, rail, etc.);
  - ii) accelerate development of regional gas and electricity projects and infrastructure in Africa to support Africa's energy transition, industrialization,

- clean cooking, agriculture, petrochemicals and open opportunities to the export of natural gas to other markets;

- iv) create interconnected multi-modal logistics zones across the continent to facilitate the movement of goods, reduce transport and distribution costs and reduce storage costs in the continent especially for the African Island States:
- v) develop intra-African shipping lines and/or dedicated regional tanker pools:
- vi) request the Commission, African Civil Aviation Commission (AFCAC) and the African Airlines Association (AFRAA) to undertake a detailed analysis on impacts related to airlines including on interconnectivity and safety, and develop a strategy for the collaboration of African airlines;
- vii) Accelerate implementation of key projects under PIDA PAP2 and African Single Electricity Market (AfSEM) to strengthen intra-Africa interconnectivity and tap into the opportunities for energy trade that the Russia-Ukraine Crisis provides for Africa;
- viii) Ensure that partnership agreements and contracts dedicate important clauses and finance for the transfer of technology, technical assistance and training of Africans as well as local, regional and continental level.

### The Executive Council,

- 1. TAKES NOTE of the Commission's report on Phase I and Phase II operationalization of the Africa Centres for Disease Control and Prevention (Africa CDC) and its recommendations;
- 2. RECALLS Decisions EX.CL/Dec.1106(XXXVII) and EX.CL/Dec.1110(XXXVIII) which requested and instructed the Commission to "prepare a report, including a road map and Framework of Operations, outlining the financial, legal and structural implications to fully operationalize the Africa CDC in line with its Statute, for submission to the Council through the AU Policy Organs";
- 3. ALSO RECALLS Decision EX.CL/Dec.1146(XL), which directed the Commission to "put in place all necessary measures to expedite the full operationalization of Africa CDC, in line with the relevant decisions of the Policy Organs, including the completion of the implementation of the Phase I Taskforce recommendations provided there are no legal, structural and financial implications and report to the 41st Ordinary Session of the Executive Council in June/July 2022";
- 4. FURTHER RECALLS Decision Assembly/AU/Dec.835(XXXV), through which the Assembly decided to "delegate its authority to the Executive Council to consider, during its July 2022 Session, the endorsement of amendments to the Africa CDC Statute in line with the following directives: a) The Africa CDC shall be an autonomous body of the Union charged with the responsibility of prevention and control of diseases in Africa; b) A new governance structure that allows for strategic leadership and ownership by the Member States at the highest level of Heads of State and Government; c) The Africa CDC Secretariat to be headed by a Director General at a proper grade; and d) The Commission to put in place modalities for full implementation of the updated Africa CDC Statute";
- **NOTES WITH CONCERN** the slow progress on implementation of the Phase I operationalization of Africa CDC;
- **REAFFIRMS** its resolve to strengthen Africa CDC, at both the Secretariat and Regional Coordinating Centre levels, for effective preparedness and response to disease threats and public health emergencies;
- **7. DIRECTS** the Commission to expedite the full implementation of the recommendations of the Phase I operationalization of Africa CDC;
- **8. REQUESTS** the Commission to submit the revised Africa CDC organizational structure and a detailed report on the operations of the Africa Epidemics Fund,

including financial, legal and structural implications, to the Executive Council in February 2023;

- **9. DIRECTS** the Commission to submit the framework of operations through the relevant process for consideration by the Executive Council in February 2023;

- COMMENDS the Commission and Member States on the establishment of the Joint Task Force on Monitoring, Evaluation and Reporting on the Implementation of Decisions of the AU Policy Organs;

- 7. **REQUESTS** the Joint Task Force to continue its work, at an accelerated pace, according to an open-ended representation of Member State experts, with a view to further developing the proposed recommendations and methodology contained in its aforementioned report;
- 8. **ALSO REQUESTS** the Commission to take all necessary measures to convene the said retreat in the second half of 2022 to review the outcome of the work of the Joint Task Force and to report to the Executive Council in February 2023;
- **9. FURTHER REQUESTS** the Commission, assisted by the Joint Task Force, to put in place all necessary measures to enhance the coordination between its 41<sup>st</sup> Ordinary Session of the Executive Council, 14-15 July 2022, Lusaka, Zambia

departments, other AU Organs and Member States on the monitoring and evaluation process of decisions through harmonized, effective and joint reporting, including the ongoing efforts of the PRC Sub-Committee on Rules, Standards and Credentials for the study on the categorization of Union decisions;

- 3. **RECALLS** its Decision EX.CL/Dec.869(XXVI) to establish ECOSOCC National Chapters as a framework for accountability of ECOSOCC members, as well as, a conduit for disseminating information and mobilizing support for AU programmes and activities including Agenda 2063;
- 4. **DIRECTS** the ECOSOCC Secretariat to finalize the Framework on the Establishment of National Chapters in Member States and submit for its consideration through the established channel in February 2023;

- 2. **COMMENDS** the leadership and personal involvement of H.E. Macky SALL, President of the Republic of Senegal and Chairperson of the Union, in resolving the crisis in the PAP which has resulted in the successful organization of the elections on 29 June 2022;
- 3. **APPRECIATES** the leadership of H.E. Cyril Ramaphosa, President of the Republic of South Africa, for having ensured the proper conduct of the elections held in Midrand, South Africa, at the Headquarters of the PAP;
- COMMENDS H.E. Moussa Faki Mahamat, Chairperson of the Commission, for the participation and the leadership demonstrated during the election proceeding of the PAP Bureau;
- 5. WELCOMES the sense of responsibility, Pan-Africanism and the spirit of compromise of the parliamentarians that prevailed during the elections and CONGRATULATES the elected members of the Bureau and all members of PAP:

- 4. **RECALLS** Decision EX.CL/Dec.1083(XXXVI) on the offer by the Republic of Equatorial Guinea to host the AUCIL Secretariat and **CALLS ON** the PRC and the Commission to expeditiously finalize the structure of an independent AUCIL Secretariat, the process of its relocation, and submit a report thereof to the Executive Council in February 2023;
- 5. **COMMENDS** the AUCIL for the timely completion of the study on the legal implications of amending Article 5(1) of the Protocol on the Establishment of the African Court on Human and Peoples' Rights to grant the African Committee of Experts on the Rights and Welfare of the Child direct access to the Court, and **DECIDES** the transmission of the study to the PRC for consideration, through its Sub-Committee on Human Rights and Governance, prior to the submission of concrete recommendations on the way forward to the Executive Council in February 2023;



- 3. REAFFIRMS the central role of the AfCHPR as the continental judicial body to ensure the achievement of the objectives of the Constitutive Act of the Union to promote and protect human and peoples' rights;
- **4. RECALLS** Decision EX.CL/Dec.1057(XXXV), and in particular Section C of the said decision "on the harmonization of allowances and benefits for Organs of the Union";
- 5. **DECIDES** to amend paragraph 14 of Decision EX.CL/Dec.1057(XXXV) to read as follows: "Also Decides to maintain the current terms and conditions of service with a view to ensuring harmonization of entitlements, allowances, benefits and conditions of service of all Judges of the African Court";





- 2. **DECIDES** to appoint, in addition to the first-tier members, the following Head of Supreme Audit Institutions on the AU Board of External Auditors (BoEA) for the 2022 and 2023 Financial Years:

  - Central Africa Republic of Congo;

# DECISION ON THE REPORT OF THE JOINT SITTING OF THE MINISTERIAL COMMITTEE ON SCALE OF ASSESSMENT AND CONTRIBUTIONS AND THE COMMITTEE OF F15, INCLUDING THE OUTCOME OF THE F15 RETREAT – Doc. EX.CL/1370(XLI)

- 1. TAKES NOTE of the report of the Joint Sitting of the Ministerial Committee on Scale of Assessment and Contributions and the Committee of Fifteen Ministers of Finance (F15);
- 2. COMMENDS Member States for contributing US\$142,823,360.89, equivalent to 70% of the US\$204,784,571.00 assessed contribution in 2022 towards the Union's regular budget;
- 3. ALSO COMMENDS Member States for contributing US\$272,470,917.00 to the AU Peace Fund since 2017, a demonstration of the high level of commitment by the Union to fully operationalize the Fund;
- 4. FURTHER COMMENDS Member States that are up-to-date with the payment of their contributions and URGES Member States that have not yet done so to pay their assessed contributions in fulfillment of their financial obligations to the Union;
- 5. RECALLS Decision EX.CL/Dec.1071(XXXV) which considered the security and political situation of the Federal Republic of Somalia and Libya and withheld the imposition of sanctions for non-payment of contributions, and which requested the Commission to consult with the two Member States to agree on a payment plan to clear the arrears within four (4) years from the adoption of the decision;
- 6. ALSO RECALLS Decision Assembly/AU/Dec.752(XXXIII), which took note of the requests from the Republic of Seychelles and the Republic of Burundi and the challenges they faced in meeting their annual contributions to the Union, and the request to the Commission to engage with Member States facing difficulties paying their contributions to the Union and those in arrears for two (2) or more years in order to agree on the payment plan for clearing their arrears;
- 7. **FURTHER RECALLS** Decision EX.CL/Dec.1119(XXXVIII), which took note of the request from the Republic of the Sudan on the need to review its assessed contribution and requested the Commission to consult with the Republic of the Sudan based on the current scale of assessment to agree on a payment plan to clear the arrears as soon possible, within four (4) years from the adoption of the decision;

**8. RECALLS** Decision Assembly/AU/Dec.802(XXXIV), which endorsed the payment plans for the Federal Republic of Somalia, the Republic of Seychelles and the Republic of Burundi to clear their arrears;

- 9. COMMENDS the Republic of Seychelles for fully implementing the payment plan which was agreed with the Commission and for clearing all outstanding arrears to AU budgets as well as paying in full the 2022 assessed contribution to the regular budget and Peace Fund and ENCOURAGES the Republic of Burundi and the Federal Republic of Somalia to continue implementing the payment plans agreed with the Commission to clear the arrears as soon as possible in line with Decision Assembly/AU/Dec.802(XXXIV);
- 10. ALSO RECALLS Decision EX.CL/Dec.1138(XXXIX), which urged Libya and the Republic of the Sudan to conclude the engagements with the Commission to agree on their respective payment plans for settling their arrears and report back to the Executive Council in February 2022;
- 11. FURTHER RECALLS Decision EX.CL/Dec.1162(XL), which took note of the report of the Commission on the on-going consultations with Libya and the Republic of the Sudan, urged the two (2) Member States to urgently finalize and submit their respective payment plans for settling their arrears to the Commission and requested the Commission to report back to the Executive Council in July 2022:
- **12. RECALLS** Decision Assembly/AU/Dec.838(XXXV), which decided exceptionally and given the well-known long-standing complex situation in Libya that, upon full payment by Libya of 50% of its arrears, the Commission shall write-off the 50% of the contributions to the regular budget due to the Union;
- 13. COGNIZANT of the lack of progress made in agreeing on a payment plan between the Commission and the Republic of the Sudan on the payment of the latter's arrears and URGES both parties to urgently conclude on the matter and report back to the Executive Council in February 2023;
- 14. URGES Libya to pay in full the 50% of its arrears for the Commission to effect the necessary write-off of the remaining 50% of its arrears;
- **15. DECIDES** to impose sanctions on the following Member States that have fallen back on the payment of their assessed contributions:
  - a. **Cautionary sanctions**: Nigeria, Ghana, Malawi, Chad, Senegal and Djibouti are to be removed from the list of countries under sanction; and
  - b. Intermediate sanctions: São Tomé and Guinea.

**16. RECALLS** Decision EX.CL/Dec.1138(XXXIX), which directed the Commission, supported by the F15 technical experts, to expedite the process of developing the new scale of assessment to be applied for the period 2023-2025 and present proposals for consideration and adoption by the Policy Organs in February 2022;

- 17. ALSO RECALLS Decision EX.CL/Dec.1162(XL), which: took note of the report of the Joint Sitting of the Ministerial Committee on Scale of Assessment and Contributions and Committee of Fifteen Ministers of Finance (F15) on the development of the new scale of assessments and the recommendation to give more time to the Commission and the F15 technical experts to gather additional data that will, in the context of COVID-19 pandemic, better reflect Member States' capacity to pay and for the necessary regional consultations to be undertaken; recommended the extension of the application of the current scale of assessment 2020-2022 by one year up to 2023; requested the Commission and the F15 technical experts to agree on a roadmap for the development of the new scale of assessment to be applied for the period 2024-2026; and further requested the Commission to report back to the Executive Council in July 2022;
- **18. FURTHER RECALLS** Decision Assembly/AU/Dec.838(XXXV), in which the Assembly decided to extend the application of the current scale of assessment 2020- 2022 by one year up to 2023;
- 19. TAKES NOTE of the roadmap agreed on by the Commission and F15 technical experts on the development of the new scale of assessment and in line with Decision Assembly/AU/Dec.838(XXXV), and REQUESTS the Commission, with the support of the F15 technical experts, to develop the new scale of assessment to be applied for the period 2024-2026 and, following the due process, present it to the Assembly for adoption in February 2023 including the relevant consultations as highlighted below:
  - a) presentation of options to the F15 technical experts for analysis: 11-12 of January 2023;
  - b) preliminary consultative meeting with Embassies in Addis Ababa to evaluate the options: 20-23 January 2023;
  - c) consultative meeting with the PRC to review and endorse the options: 27 January 2023;
- 20. RECALLS Decision EX.CL/Dec.1119(XXXVIII), which mandated the Commission to continue bilateral consultations with countries according to the reservations on Decision EX.CL/Dec.1100(XXXVII) on the use of the scale of assessment for the regular budget to assess Member States to the AU Peace Fund with a view to arriving at the appropriate mechanism for assessing the Peace Fund as long as it does not affect the consensus already agreed on the matter and the reservations made thereof;

21. ALSO RECALLS Decision EX.CL/Dec.1138(XXXIX), which directed the Commission and urged six (6) Member States that have entered the reservation to finalize the consultations before the Executive Council in February 2022;

- **22. FURTHER RECALLS** Decision EX.CL/Dec.1162(XL), which: took note of the proposal made by the six (6) Member States of the Northern Region that expressed reservations on Decision EX.CL/Dec.1100(XXXVII) on the use of the scale of assessment for the regular budget to assess Member States to the AU Peace Fund and its implications on the total endowment of the Peace Fund; directed the Commission to work closely with the F15 and the Office of the Legal Counsel to analyze the proposals made and the implications thereof; recommended solutions in accordance with the legal framework of the Union; and further directed the Commission, guided by the solutions recommended thereof, to continue consultations with the concerned Member States from the North and other regions to agree on a mechanism for contributions to the Peace Fund and report back to the Executive Council in July 2022;
- 23. TAKES NOTE of the progress and the proposals made and URGES the Commission and the F15 to finalize the analysis of the proposals made by the six (6) Member States of the Northern Region including the consultations as prescribed in Decision EX.CL/Dec.1162(XL) and report back to the Executive Council in February 2023;
- 24. RECALLS Decision EX.CL/Dec.1162(XL) that took note of the concern raised regarding the concentration of investments in two (2) banks from one (1) region and expresses its concern on the delay on implementation of the decision;

RECALLS Decision Assembly/AU/Dec.578(XXV), which adopted the Union's self-financing targets of 100% for the operational budget, 75% for the program budget and 25% for the peace support operations budget and FURTHER RECALLS Decision Assembly/AU/Dec.605(XXVII), whereby the Assembly reaffirmed its determination to ensure that the Union is financed in a predictable, sustainable, equitable and accountable manner with the full ownership by its Member States;
- **3. ALSO RECALLS** Decision Assembly/AU/Dec.687(XXX), which endorsed the budget oversight role and functions of the F15 and adopted the Golden Rules that provide a framework for financial management and accountability principles at the Union:
- 4. RECALLS Decision Assembly/AU/Dec.733(XXXII), which mandated the Commission to provide technical support to Member States in accelerating the implementation of the 0.2% import levy and further reaffirmed that Member States, while implementing the decision, will be availed flexibility in fulfilling their obligations, as per their constitutional provisions and national laws, in accordance with Rule 33 of the Rules of Procedure of the Assembly;
- 5. FURTHER RECALLS Decision Assembly/AU/Dec.819(XXXV), which urged Members States to accelerate implementation of the 0.2% levy on eligible imports, determined in July 2016, with a view to reaching at least thirty-five (35) Member States fully implementing the levy:
- 6. ALSO RECALLS Decision Assembly/AU/Dec.821(XXXV) adopting the Revised AU Financial Rules and **TAKES NOTE** of Rule 94(2) on the Committee of Fifteen Ministers of Finance (F15), which stipulates that the F15 shall develop its rules of procedure which shall be adopted by the Assembly;
- **7. URGES** Member States to promptly pay their assessed contributions in adherence to Rule 23(1) of the AU Financial Rules, with the objective to address program implementation challenges directly associated with cash-flow constraints;

8. APPRECIATES the determination by the F15 to support the ongoing budget and financial reforms of the African Union and ENDORSES the commitment to reinforce the processes with a robust tri-annual review of the Union's financial management, budgetary and accountability principles, and to recommend periodic improvements including through a budget performance assessment mechanism to be set in place by the F15;

- **9. DIRECTS** the Commission, upon the request of Member States, to intensify technical and advisory support to address the pending concerns of the alignment and harmonization of the 0.2% import levy mechanism with their national laws, including alignment with the various bilateral and multilateral trading systems, bearing in mind the flexibility stipulated in Decision Assembly/AU/Dec.733(XXXII);
- 10. REQUESTS the Committee of Fifteen Ministers of Finance (F15) to continue and finalize consultations on its draft rules of procedure for presentation to the Policy Organs in February 2023, and STRESSES that the membership of the F15 shall comprise three (3) Member States per region to be constituted on the basis of the principles of equal sovereignty, rotation and solidarity as per the established practice;

 provide continuous high-level political ownership and leadership to guide the Commission, AUDA-NEPAD (lead AU bodies tasked with implementation and M&E of Agenda 2063) supported by the technical working group, in the execution of the special project;

ii. provide the necessary financial, material and technical support to the Ministries of Planning and Finance as well as Planning Authorities, where applicable, to facilitate the multi-stakeholder consultations; in supplement of AUDA/NEPAD technical and seed financial contribution of US\$1,000,000.00 (US\$20,000.00 per country);

- iii. leverage existing and new collaboration and partnership arrangements with RECs, AU bodies, AfDB, the UN System (e.g. AU-UN Partnership Framework) and other development actors to undertake the national multistakeholder consultations, and subsequently submit national-level consultation reports by mid-September 2022;
- iv. provide dedicated focal points in the Ministries to facilitate participation of all stakeholders including non-state actors, private sector, faith-based organizations, learning and research institutions, women and youth groups in the implementation of the special project, buttressed on enhanced advocacy and awareness of Agenda 2063, which henceforth would become the People of Africa's Agenda;
- v. enhance data and statistics capacities and strengthen multi-stakeholder dialogue platforms for collective and continuous review, reflection and knowledge exchange on the design and implementation of Agenda 2063;
- 8. REQUESTS the Commission to fast-track the work of the review of the First Ten-Year Implementation Plan and the Formulation of the Second Ten-Year Implementation Plan of Agenda 2063, and present the report thereof to the Executive Council in February 2023.
