

DECISION ON THE BUDGET FOR THE AFRICAN UNION FOR THE 2009 FINANCIAL YEAR Doc. EX.CL/455 (XIV)

- **1. APPROVES** the Budget of the African Union (AU) for the Financial Year 2009amounting to US\$164,256,817 to be distributed as follows:
 - i) A total amount of US\$ 93,804,243 assessed to Member States on the basis of the approved Scale of Assessment;
 - ii) A total amount of US\$57,412,574 earmarked for the programmes secured from International Partners;
 - iii) An amount of 13,040,000 to be financed from forty percent (40%) of the Surpluses from the Year 2004 to 2007 Budgets;
- **2. APPROVES** the Budget breakdown between the AU Organs as follows:

- 3. REQUESTS the Commission to develop templates for budget formulation and presentation, and submit them to the Permanent Representatives Committee (PRC) through its Sub-Committee on Administrative, Budgetary and Financial Matters for consideration;
- **4. DECIDES** that all AU Organs, namely PAP, ACHPR, AfCHPR and ECOSOCC shall work closely with the Commission in the preparation of their respective budgets to ensure that they comply with the AU Financial Rules and Regulations and the AU Staff Rules and Regulations, as well as the standardized templates of budget formulation and presentation;
- **5. REQUESTS** the Commission to ensure that ledger codes of budgets of all AU Organs are standardised;

- **6. ALSO REQUESTS** the Office of the Internal Audit of the Commission to periodically audit the accounts of all other AU Organs;
- **7. REQUESTS** the Commission to ensure that the expenses of the Board of External Auditors be centralised under the Commission Budget;
- **8. REQUESTS** the Commission to monitor the budget preparation by all AU Organs in order to ensure compliance with the AU Financial Rules and Regulations and the AU Staff Rules and Regulations;
- **9. FURTHER REQUESTS** all AU Organs to submit monthly returns to the Commission for the purpose of monitoring budget execution and compliance with the AU Financial Rules and Regulations;
- 10. **DECIDES** that all AU Organs shall submit their requests for virement in conformity with the AU Financial Rules and Regulations to the PRC through its Sub-Committee on Administrative, Budgetary and Financial Matters for consideration;
- 11. REQUESTS the Commission to verify the recruitment process of staff members within all the AU Organs and ensure that the recruitment contracts are standardized;
- **12. ALSO REQUESTS** the Commission to discuss future draft budgets with the Bureau of the Sub-Committee on Administration, Budgetary and Financial Matters before submitting them to the Sub-Committee for consideration.

13. REQUESTS PAP:


- to stop applying fifty-eight percent (58%) Post Adjustment Allowance to its staff members as and when their contracts expire, and apply the forty percent (40%) rate as per the AU Staff Rules and Regulations;
- ii) to send to the Commission copies of contracts for the members of staff who will be affected by this Decision;
- iii) to calculate Post Adjustment Allowance on basic salary only without including the housing allowance;
- iv) to stop implementing any decisions of the Bureau of PAP which have financial implications until approved by the AU Policy Organs;
- v) to submit the Organizational Structure of PAP to the Sub-Committee on Structures for consideration prior to the July 2009 Summit;
- vi) to adhere strictly to the AU Financial Rules and Regulations and the Staff Rules and Regulations in the preparation and execution of the Budget, as well as the provisions of Article 15 of PAP's Protocol dealing with budget preparation;

- vii) not to include any unauthorized budget lines in the 2009 Budget in particular the Sitting, Advocacy and Communication, Coordination and Responsibility Allowances.
- viii) to apply the Daily Subsistence Allowance (DSA) rates as per the AU Financial Rules and Regulations;
- ix) to stop paying higher housing allowance rates and apply the AU approved rates.



DECISION ON THE USE OF SURPLUS

- **1. APPROVES** the use of ten percent (10%) of surplus to replenish the Working Capital with an amount of US\$3,260,000 from the surplus of the period 2004 to 2007;
- 2. ALSO APPROVES the review and increase of the amount allocated to the acquisition of AU Properties from fifteen percent (15%) to twenty percent (20%) of the arrears of contributions;
- **3. FURTHER APPROVES** that forty percent (40%) of the surplus accumulated during the period 2004 2007 be used to finance this year's Budget;
- 4. REQUESTS the Commission to make proposals on the review of the relevant articles in the AU Financial Rules and Regulations on the use of Surplus and Deficits.



DECISION ON OTHER FINANCIAL MATTERS

- **1. APPROVES** the payment of an honorarium of two hundred United States Dollars (US\$200.00) per day to the Members of the Board of External Auditors (Board) plus twenty percent (20%) for the Chairperson of the Board;
- 2. REQUESTS the Commission, in consultation with the Permanent Representatives Committee (PRC) to appoint as soon as possible an independent auditing firm to conduct a forensic audit of the African Union Mission in Sudan's (AMIS) accounts and submit a report to the Executive Council at its next Ordinary Session in July 2009.



DECISION ON THE CONTRIBUTIONS OF MEMBER STATES Doc. EX.CL/453 (XIV)

- **1. TAKES NOTE** of the Report on the contributions of Member States;
- 2. APPRECIATES that the following Member States are up to date with the payment of their contributions to the Regular Budget: Algeria, Angola, Botswana, Burkina Faso, Congo, Egypt, Ethiopia, Ghana, Equatorial Guinea, Kenya, Lesotho, Liberia, Libya, Malawi, Namibia, Mauritania, Mozambique, Niger, Democratic Arab Saharawi Republic, Rwanda, Senegal, South Africa, and Zambia and ENCOURAGES other Member States to pay their assessed contributions in full and on time;
- 3. **EXPRESSES CONCERN** at the late payment of contributions by some Member States;
- **4. URGES** Member States in arrears of their contributions to urgently pay up their arrears;
- 5. **DECIDE**S that the temporary exemptions granted to Burundi and Sierra Leone from sanctions be maintained so long as they honour their agreed payment schedule and **URGES** these Member States to continue to comply with the agreed rescheduling plan;
- **6. DECIDES** to maintain the sanctions on the following Member States:
 - i) Cape Verde
 - ii) Democratic Republic of Congo
 - iii) Eritrea
 - iv) Sao Tomé & Principe
 - v) Seychelles
- 7. CONSIDERS FAVOURABLY the request by Seychelles to reschedule its arrears and REQUESTS the Commission to convey this position to the Government of Seychelles;
- **8. TAKES NOTE** of the statement by the Democratic Republic of Congo (DRC) and does not accept the proposal of DRC to offer buildings to cover its arrears;
- **9. DECIDES** on the non-exemption from exceptional measures for post-conflict countries until conclusion by the Commission of the study on the matter and appropriate recommendations thereon considered and adopted;
- **10. REQUESTS** the Chairperson of the Commission to explore the possibility of opening a dialogue with the five (5) countries under sanctions in order to convince them to pay up their arrears and be up-to-date in respect of their status as members of the African Union.

DECISION ON THE AU 2009 CALENDAR OF MEETINGS Doc. EX.CL/453(XIV)d

- **1. TAKES NOTE** of the Report of the Permanent Representatives Committee (PRC) on the Draft 2009 African Union (AU) Calendar of Meetings;
- 2. **REAFFIRMS** the provisions of its previous Decision EX.CL/Dec.419 (XIII) adopted by its Thirteenth Ordinary Session held in Sharm El Sheikh, Egypt from 27 to 28 June 2008;
- 3. **COMMENDS** the Commission, in particular the Conference Services Directorate for the tremendous efforts it has exerted in improving the quality and timely delivery of services to facilitate the smooth conduct of meetings;
- 4. **REQUESTS** the Commission to avoid, in the planning and organization of its future meetings, the overlapping and congestion of such meetings within specific months;
- 5. **ENCOURAGES** the Commission to rationalize all its meetings and also reduce the number of summits and ministerial meetings held in one single year;
- 6. **EMPHASISES** the need to align meetings to the approved budgetary allocations without allowing it to negatively affect the effective and smooth servicing of such meetings;
- 7. **REQUESTS** the Commission to ensure proper coordination and consultation between its various Departments when organizing meetings on the same themes involving the same stakeholders;
- 8. **DECIDES** that meetings not reflected in the approved Calendar of Meetings shall not be organized by the Commission;
- 9. REITERATES the need for the Commission to ensure that religious events and national holidays are taken into account when preparing its Calendar of Meetings;
- **10. REQUESTS** the Commission to ensure that working documents including reports of meetings, particularly those of ministerial nature are prepared timely, and delivered to Member States;
- **11. ALSO REQUESTS** the Commission to discourage Departments from preparing meetings through direct contacts with capitals of Member States and without the knowledge or involvement of their Permanent Representatives to the AU:

- **12. FURTHER REQUESTS** the PRC in collaboration with the Commission to finalize the 2009 Calendar of Meetings as soon as possible after the January 2009 Summit;
- **13. FINALLY REQUESTS** the Commission to monitor the implementation of this Decision and submit a report thereon to the next ordinary session of the Executive Council in July 2009.



DECISION ON THE STATUS OF SIGNATURE AND RATIFICATION OF OAU/AU TREATIES AND THE HARMONIZATION OF RATIFICATION PROCEDURES Doc. EX.CL/458(XIV)

- **1. TAKES NOTE** of the Report on the Status of Signature and Ratification of OAU/AU Treaties:
- 2. FURTHER TAKES NOTE of the Report of the Conference of Ministers of Justice and/or Attorneys General held in Kigali, Rwanda from 27 October to 4 November 2008:
- **3. REITERATES ITS APPEAL** to Member States to urgently sign and ratify/accede to all OAU/AU Treaties and in any event to commence the process of ratification within the next one year for existing treaties not yet ratified or acceded to; and within one year of adoption of future treaties;
- 4. ENDORSES the recommendations of the Conference of Ministers of Justice and/or Attorneys General relating to the Procedures for Ratification of Treaties in Member States, and Measures to Speed up the Ratification of OAU/AU Treaties including those intended to:
 - (i) encourage ratification of OAU/AU treaties;
 - (ii) harmonize ratification procedures and speed up ratification of OAU/AU treaties;
 - (iii) address the problem of inconsistency between different linguistic texts;
 - (iv) ensure speedy implementation of treaties.
- 5. REQUESTS Member States and the Commission to implement the respective recommendations relating to the Procedures for Ratification and Measures to Speed up the Ratification of OAU/AU Treaties addressed to them;
- 6. URGES Member States to commence the process of ratification of AU treaties within one (1)year of their adoption;
- 7. REITERATES ITS APPEAL to the Pan-African Parliament to assist with advocacy and sensitization of Member States to expedite the process of ratification/accession to OAU/AU Treaties;
- **8. DECIDES** to institutionalize the AU Treaty Signing Week in December of each year;
- **9. REQUESTS** the Commission to take the necessary steps to expedite the implementation of the previous decisions of the Executive Council on the review of OAU/AU Treaties and to report thereon to the next Ordinary Session of the Executive Council scheduled for July 2009;

10. FURTHER REQUESTS the Commission to follow-up on the implementation of this Decision and to report regularly to the Executive Council on progress made.



DECISION ON THE REVIEW OF THE PROTOCOL RELATING TO THE PAN-AFRICAN PARLIAMENT (PAP) DOC. EX.CL/459 (XIV)

- **1. TAKES NOTE** of the Report of the Commission on the Review of the Protocol relating to the Pan-African Parliament (PAP);
- 2. AUTHORIZES the Commission to initiate the review process of the Protocol to the Treaty establishing the African Economic Community relating to the Pan-African Parliament;
- 3. **REQUESTS** the Commission to draft and finalize the Terms of Reference for the review in consultation with the Permanent Representatives Committee (PRC), taking into account the views of PAP;
- 4. FURTHER REQUESTS the Commission to carry out a comprehensive study on the review of the Protocol based on the Terms of Reference, taking into account the views of PAP and make appropriate recommendations thereon to the African Union (AU) Policy Organs, through the PRC, for consideration at their next Ordinary Sessions in July 2009;
- 5. ALSO REQUESTS PAP to amend its Rules of Procedure to conform to the legal instruments of the AU;
- 6. FINALLY REQUESTS PAP to urgently fix a term limit for its Bureau, drawing inspiration from other AU organs and to immediately hold new elections to renew the mandate of the current Bureau or elect a new one.

DECISION ON THE IMPLEMENTATION OF THE AFRICAN UNION BORDER PROGRAMME (DOC. EX. CL/459 (XIV)]

- **1. TAKES NOTE** of the Report of the Chairperson of the Commission on the Implementation of the African Union Border Programme (AUBP);
- 2. **RECALLS** Decision EX.CL/Dec.370 (XI) adopted at its Eleventh Ordinary Session held in Accra, Ghana, from 28 to 29 June 2007, through which Council endorsed the AUBP;
- **3. WELCOMES** the progress made in the implementation of the AUBP;
- 4. **ENCOURAGES** the Commission to persevere in its efforts, in particular through the pursuit of the enhancement of its capacities, notably in terms of human resources, the sensitization campaign on the AUBP, the launching of consultancies on the key components of the AUBP, the elaboration of a legal instrument on cross-border cooperation, the initiation of a programme of exchange of experiences and best practices and the convening of the Second Conference of African Ministers in charge of Border Issues;
- 5. INVITES Member States to take all the necessary measures to fully play their role in the implementation of the AUBP, and FURTHER INVITES those countries that have not yet done so to respond as soon as possible to the questionnaire on the state of African borders, to accelerate the delimitation and demarcation process of African borders where such an exercise has not yet taken place, through dialogue, and to take all the necessary steps to strengthen local initiative on cross-border cooperation;
- 6. **EXPRESSES ITS GRATITUDE** to the Government of the Federal Republic of Germany for its assistance to the implementation of the AUBP, and **URGES** the other African Union (AU) partners to support the implementation of the AUBP and, where relevant, honour the commitments made;
- 7. **ENCOURAGES** the Commission to take initiatives to develop cross-border cooperation, both as an indispensable complement of delimitation and demarcation of African borders, where this has not yet been done;
- **8. FURTHER ENCOURAGES** the Commission to take all the necessary steps to ensure that the 2012 deadline set by the Memorandum of Understanding on Security, Stability, Development and Cooperation in Africa (CSSDCA) for the delineation and demarcation of all borders is achieved as much as possible;
- **9. REQUESTS** the Commission to ensure that the AUBP is implemented on the basis of the principle of subsidiarity, taking into account the respective roles incumbent on the Member States, the Regional Economic Communities (RECs) and the AU;

- **10. ALSO REQUESTS** the Commission to continue to work actively towards the establishment of partnerships with organizations that have experience in the management of border issues, in particular the United Nations, the European Union and the Organization of American States;
- **11. FURTHER REQUESTS** the Commission to report regularly on the implementation of the AUBP.



DECISION ON THE REPORT ON THE SITUATION OF REFUGEES, RETURNEES AND INTERNALLY DISPLACED PERSONS IN AFRICA Doc. EX.CL/460 (XIV)

- **1. TAKES NOTE** of the Report on the Situation of Refugees, Returnees and Internally Displaced Persons in Africa;
- 2. **EXPRESSES CONCERN** over the recurrent challenging problems of refugees, returnees and internally displaced persons in some regions of the African continent;
- 3. WELCOMES the holding and positive outcome of the meetings of AU Member StateS Experts in-charge of Forced Displacement issues, the Legal Experts on the Draft AU Convention for the Protection and Assistance of Internally Displaced Persons in Africa and the Second Ministerial Conference on Refugees, Returnees and Internally Displaced Persons, which took place in November 2008, in Addis Ababa, Ethiopia, towards the preparations of the AU Special Summit of Heads of State and Government on Refugees, Returnees and Internally Displaced Persons in Africa, scheduled for April 2009, in Kampala, Uganda;
- 4. CONGRATULATES Member States on their assistance programmes to refugees, returnees and internally displaced persons and REQUESTS countries of asylum to reinforce their assistance machineries in order to make them more effective:
- 5. STRESSES the need for more assistance to the countries of asylum to enable them to properly shoulder their increased responsibilities and assume the additional burden caused by the presence of refugees on their economies;
- 6. CALLS UPON the International Community to honour its pledges and extend assistance to countries of origin for the repatriation, resettlement and rehabilitation of returnees to ensure their sustainable integration;
- 7. REQUESTS Member States to provide the Commission with up-to-date statistics on refugees, returnees and internally displaced persons in order to enable the Commission to reflect the true picture of the humanitarian situation in their countries; and
- **8. WELCOMES** the offer by the Republic of Uganda to host the first ever AU Special Summit of Heads of State and Government on Refugees, Returnees and Internally Displaced Persons in Africa.

DECISION ON THE REPORT OF THE COMMISSION ON THE IMPLEMENTATION OF DECISION EX.CL/Dec. 408(XII) ON THE COMMEMORATION OF THE ABOLITION OF SLAVERY Doc. EX.CL/461(XIV)

- **1. TAKES NOTE** of the Report on the Implementation of Decision EX.CL/Dec.408(XII) on the Commemoration of the Abolition of Slavery;
- 2. **EXPRESSES SATISFACTION** at the success of the Experts Group Meeting on Slavery and the follow up to the World Conference Against Racism held in Banjul, The Gambia, pursuant to Decision EX.CL/Dec. 408(XII) on the "Commemoration of the Abolition of Slavery";
- **3. EXPRESSES GRATITUDE** to the Government of the Republic of The Gambia for hosting the Meeting;
- 4. **WELCOMES** the hosting by the Government of the Federal Republic of Nigeria of the African Regional Conference preparatory to the Durban Review Conference:
- International Day of Remembrance of the Victims of Slavery and the Transatlantic Slave Trade by the United Nations, the African Union and the Caribbean Community (CARICOM) at the United Nations Headquarters in New York on 25 March 2008;
- 6. FURTHER EXPRESSES SATISFACTION at the organization of the seminar for the African Group in Geneva on preparations for the Durban Review Conference, on 5 April 2008 by the African Union (AU) Permanent Mission in Geneva:
- 7. APPEALS to Member States and the International Community to get fully engaged with the Durban Review Process, by expressing their political will in that connection and providing support towards the financing of the process;
- **8. CALLS UPON** Member States to provide the Commission with information on national efforts to end contemporary forms of slavery;
- 9. - **10. FURTHER REQUESTS** the Commission, in collaboration with the African Diaspora to undertake further study on slavery and its contemporary forms with special emphasis on issues related to reparations covering the colonial

period, taking into account the work undertaken by the Committee on Reparations established in conformity with OAU Resolution CM/Res.1339(LIV) adopted in Abuja, Federal Republic of Nigeria, in June 1991, and report to the next Ordinary Session of the Executive Council in July 2009;

11. CALLS UPON the Commission to react to racist and other attacks on African migrants, whenever they occur.

- **1. TAKES NOTE** of the Plan of Action for the Implementation of the Great Green Wall for the Sahara and Sahel Initiative:

- **2. DECIDES,** based on the review, to increase the basic salaries of all elected officials and staff members of the Commission in the following manner:

a. Staff in the General Service (GS) category: 25%
b. Staff in the Professional category: 20%
c. Elected officials: 15%

- 3. ALSO DECIDES that the increase shall take effect from 1 January 2009.
- 4. FURTHER DECIDES on the payment of a Non-Resident Allowance for internationally recruited GS staff at the rate of US\$3000 and US\$2400 per year for staff with dependants and those without dependants respectively.


DECISION ON THE SITUATION IN THE MIDDLE EAST AND PALESTINE DOC. EX.CL/486(XIV)

- 1. TAKES NOTE of the Report on the Situation in the Middle East and Palestine; and RECALLS all resolutions and decisions adopted by the OAU/AU on the Situation in Palestine and the Middle East;
- 2. REITERATES its full support for the legitimate struggle of the Palestinian people against the Israeli occupation under the leadership of the Palestine Liberation Organization (PLO), their sole and legitimate representative, to obtain their inalienable national rights, including their right to self-determination, return to their homeland and to their property, and to live in peace and stability in an Independent Palestinian State with Al-Quds Al-sharif (Jerusalem) as its capital, in accordance with the principle of international law, all pertinent United nations (UN) Resolutions, particularly resolution 194, which calls for the return of refugees to their homeland and properties, and the resolutions and decisions of the OAU/AU;
- 3. REAFFIRMS its support to end the Arab-Israeli conflict peacefully and on the basis of the principles of international law and all relevant resolutions; and CALLS UPON Israel to end their occupation of the Palestinian and Arab territories:
- 4. REQUESTS the United Nations (UN) Security Council to shoulder its major responsibilities under its charter in maintaining international peace and security in order to achieve a comprehensive, just, and lasting peace; and CALLS UPON the international community to exert pressure on Israel;
- 5. STRONGLY CONDEMNS the barbaric attacks launched by the Israeli forces on the Gaza Strip resulting in the death and injuries of thousand of innocent civilians as well as massive destruction of property; and CALLS ON the UN Security Council to carry out investigations into the violations of human rights and war crimes perpetrated during these aggressions, including the use of prohibited weapons with a view to bringing the perpetrators to justice;
- **6. URGES** Israel to immediately and unconditionally withdraw from the occupied areas;
- 7. CALLS UPON Israel to implement the UN Security Council Resolution 1860, which calls for "an immediate, durable and fully respected ceasefire" and lifting of the siege imposed on Gaza by ensuring "the sustained reopening of the crossing points on the basis of the 2005 agreement"; as well as "the unimpeded provision and distribution throughout Gaza of humanitarian assistance, including food, fuel and medical treatment";
- **8. WELCOMES** the Egyptian initiative as a mechanism for the implementation of the UN Security Council Resolution 1860, and which also calls for an immediate ceasefire, the lifting of the siege and to guarantee international protection for civilians;

- 9. **EXPRESSES** its support for the negotiations between the Palestinian and Israeli sides in order to reach a peaceful, comprehensive, just and lasting solution to the ongoing conflict in the Middle East, and **CALLS UPON** Israel to accept the International efforts aimed at establishing the independent Palestinian State with Al-Quds Al-Sharif (Jerusalem) as its capital, and to respond to the demands of the International Community;
- **10. WELCOMES** the Arab Summit's Resolution adopted in Damascus and all the efforts made by sisterly and friendly countries particularly the sustained and sincere efforts deployed by the Arab Republic of Egypt;
- **11. EXPRESSES** its profound appreciation for the efforts made by the Palestinian leadership for the achievement of peace;
- 12. **DEMANDS** that the Israeli Government stops all unilateral measures and decisions aimed and designed to create a new reality in the Occupied Palestinian Territories, particularly the continuous building of illegal settlements as a new geopolitical reality; and **FURTHER DEMANDS** that the Israeli Government immediately ceases all settlement activities in the Palestinian Occupied Territories and to remove the Apartheid Separation Wall that was built on an Occupied Palestinian Territory, as well as to comply with the decision of the International Court of Justice and the UN General Assembly Resolution in this regard; and **URGES** the International Community to exert pressure on Israel to stop all settlement activities in the Occupied Palestinian Territories;
- Aqsa Mosque, and the deliberate destruction of places of archaeological significance and heritage in the city of Al-Quds (Jerusalem); and **DEMANDS** that all countries, the United Nations Education, Scientific and Cultural Organization (UNESCO) and the Committee of Global Archaeology take severe sanctions against Israel for its provocative measures that constitute a dangerous threat for the global archaeological treasure;
- 14. EXPRESSES DEEP CONCERN regarding the worsening humanitarian situation and increasing sanitary and economic deterioration in the Palestinian Occupied Territories, particularly in the Gaza Strip, due to the constant siege, ongoing daily Israeli invasions, restrictions on the movement of persons and constant closures and blockades of the Palestinian commercial crossing points with neighboring countries; and DEMANDS that the Israeli authorities remove them immediately and without delay and to re-open all crossing points;
- **15. DENOUNCES** the repressive practices and policies, particularly the continuous invasions, daily assassinations, brutal assaults, the demolitions and arrests committed against civilians, innocent and defenceless people in the Palestinian Occupied Territories including Al-Quds Al-Sharif (Jerusalem) its capital, that claimed hundreds of lives during the past months;
- **16. EXPRESSES GRAVE CONCERN** over the deterioration of the living and health conditions of Palestinian prisoners and detainees in Israeli jails;

DENOUNCES and **CONDEMNS** all Israeli inhuman practices against prisoners and detainees;

17. FINALLY CALLS UPON the Government of Israel to put an end to its occupation of all Arab lands occupied since 1967, including the Syrian and Lebanese territories, and to abide by the relevant UN Security Council Resolutions, particularly Resolutions 242 and 338, the Madrid Declaration, the Land for Peace Principle, and the Road Map, in order to reach a just, comprehensive, lasting and peaceful solution to the Arab-Israeli Conflict.




DECISION ON THE STRATEGY FOR THE IMPLEMENTATION OF THE PLAN OF ACTION FOR THE ACCELERATED INDUSTRIAL DEVELOPMENT OF AFRICA Doc. EX.CL/476 (XIV)

- 1. TAKES NOTE of the Report of the Commission on the First Ordinary Session of the Conference of African Union (AU) Ministers of Industry/Eighteenth Session of the Conference of African Ministers of Industry (CAMI-18);
- **2. ENDORSES** the Strategy for the Implementation of the Plan of Action for the Accelerated Industrial Development of Africa;
- 3. ALSO ENDORSES the Declaration adopted by the Conference of AU/African Ministers of Industry held in Durban, South Africa on 28 October 2008;
- 4. REQUESTS the Commission, in collaboration with United Nations Industrial Development Organization (UNIDO) and the Regional Economic Communities (RECs), to organize regional meetings in Africa for the dissemination of the Action Plan for the Accelerated Industrial Development of Africa and the Strategy for the Implementation:
- 5. REQUESTS Member States, the RECs, private sector institutions and operators, development partners and other stakeholders, to take necessary measures for the effective implementation of the Action Plan for the Accelerated Industrial Development of Africa;
- 6. UNDERSCORES the importance of availing the necessary financial resources for the operationalisation of the Plan of Action for the Accelerated Industrial Development of Africa, and CALLS on Member States to dedicate adequate national resources for industrial development;
- 7. ALSO CALLS on the Commission, the RECs and other African and international institutions to assist in the mobilization of resources for Africa's industrial development through, inter alia, the development of appropriate financial instruments and mechanisms:
- **8. WELCOMES** the offer made by the Arab Republic of Egypt for five hundred (500) scholarships to other African Countries in the different sectors of industry as well as the launching of the South-South Industrial Cooperation Centre;
- **9. REQUESTS** the Commission, in collaboration with UNIDO, to submit to the Executive Council, every two years, progress reports on the implementation of the Plan of Action for the Accelerated Industrial Development of Africa.

DECISION ON MULTILATERAL COOPERATION DOC. EX. CL/462 (XIV)

- **1. TAKES NOTE** of the Report of the Commission on the activities relating to multilateral cooperation and various partnerships;
- **2. ALSO TAKES NOTE** of the progress made in the preparation for the various summits scheduled to take place during the year 2009;
- 3. **RECALLS** that these partnerships are vital to the process of Africa's development and **URGES** for maximum preparation in order for Africa to fully appropriate the benefits and opportunities of these partnerships;
- **4. FURTHER RECALLS** the successful conduct of the Africa-Turkey Partnership Summit that was held in Istanbul, Turkey in August 2008;
- 5. CALLS ON Member States to fully participate in the implementation of the outcomes of the Africa-Turkey Partnership Summit, the Africa-India Forum Summit, and TICAD IV;
- 6. **REQUESTS** the Commission to continue to work closely with the relevant AU organs with a view to concluding the joint plan of action of the Africa-India Forum Summit, and to develop that relating to the Africa-Turkey Partnership Summit in order to derive maximum and concrete benefits;
- 7. **NOTES WITH APPRECIATION** the concrete proposals made by India with ear-marked funding within the framework of the Africa-India Forum Summit;
- 8. ALSO NOTES the proposal by the Venezuelan Government to host the Second Africa-South America Summit in August 2009, in Venezuela and REQUESTS the Commission to liaise with the host with the view to proposing specific dates;
- 9. FURTHER TAKES NOTE of the proposal by the Commission and the General Secretariat of the Organization of Islamic Conference to review the draft Agreement between them, approved by the Council of Ministers of the Organization of African Unity (OAU) in 2000, and REQUESTS that the outcome be brought to the attention of this Council in due course;
- 10. FURTHER REQUESTS the Commission to conclude the global review, study of all the existing partnerships and report to the next Session of the Executive Council in July 2009, and DIRECTS that no new partnership be considered until the review has been concluded;
- **11. RECOMMENDS** to the Assembly that the partnership summits scheduled to take place this year be held as follows:
 - i. Africa-South America Summit, during the month of August 2009, with the specific date being agreed through consultation;

- ii. Africa-Diaspora Summit later in the year 2009, in South Africa, at a date to be mutually agreed upon with the host country;
- iii. The Second Afro-Arab Summit on a date to be agreed upon.
- **12. REQUESTS** the Commission to take all necessary measures to participate in the preparation and holding of future meetings of the partnerships with China and Japan, as per previous decisions on this issue;
- **13. STRESSES** the need to ensure harmony of strategies within various partnerships and **REQUESTS** the Commission to appoint a coordinator to that effect.



DECISION ON THE AFRICAN UNION COMMISSION STRATEGIC PLAN 2009-2012 EX.CL/454 (XIV)

- **1. TAKES NOTE** of the presentation by the Commission of the Draft Strategic Plan 2009-2012 and the comments and observations of the Permanent Representatives' Committee (PRC) contained in document PRC/Rpt(XVII);
- 2. **COMMENDS** the Commission for the work carried out and the quality of the Strategic Plan document and **STRESSES** the need for the Commission to work closely with the PRC in order to finalize this document;
- **3. ACCEPTS,** in principle, the missions and objectives of the African Union Commission on which the African Union Strategic Plan for the period 2004-2007 is built:
- 4. REAFFIRMS that, in order to achieve continental integration, the Commission, Member States, the Regional Economic Communities (RECs) and the other AU organs, key partners and stakeholders, including civil society and the private sector must work in synergy, on the basis of shared values of the Union;
- 5. AUTHORIZES the Chairperson of the Commission to take appropriate measures to ensure that support structures, programs, projects and budgets drawn up from the former Strategic Plan 2004 2007 are carried out appropriately, pending the adoption of the 2009-2012 Strategic Plan;
- 6. **REQUESTS** the Commission in collaboration with the PRC to submit the Plan to the next Ordinary Sessions of the Executive Council and Assembly in July 2009 for final adoption.

DECISION ON THE TWENTY FIFTH ACTIVITY REPORT OF THE AFRICAN COMMISSION ON HUMAN AND PEOPLES' RIGHTS Doc. EX.CL/490 (XIV)

- **1. TAKES NOTE** of the Twenty-Fifth Activity Report of the African Commission on Human and Peoples' Rights (ACHPR);
- 2. ADOPTS and AUTHORIZES, in accordance with Article 59 of the African Charter on Human and Peoples' Rights (the African Charter), the publication of the Twenty-Fifth Activity Report of the ACHPR and its annexes;
- 3. **COMMENDS** the ACHPR for its accomplishments in the promotion and protection of human and peoples' rights in 2008 and **URGES** that it continues to pursue and intensify its efforts in this regard;
- 4. REQUESTS the ACHPR to identify possible ways to overcome shortcomings in the functioning of the communications mechanism that might result from, inter alia, human and financial resources constraints, as previously referred to in paragraph eleven (11) of Decision Assembly/AU/Dec.200(XI);
- 5. REITERATES its request to the ACHPR to present a report on this issue in accordance with paragraph 12 of Decision Assembly/AU/Dec.200(XI) and FURTHER UNDERSCORES the importance of addressing effectively and promptly these issues in order to support the ACHPR in discharging its mandate in the most efficient, professional and objective manner;
- ADOPTS the new structure of the Secretariat of the ACHPR proposed by the PRC and CALLS UPON the relevant Departments of the African Union Commission (AUC) to ensure the implementation of this structure in accordance with the relevant AU Rules and Regulations;
- 7. **COMMENDS** the ACHPR for finalising its Interim Rules of Procedure and transmitting the Rules to stakeholders, including States Parties to the African Charter:
- 8. CALLS ON the ACHPR and the African Court on Human and Peoples' Rights to expedite the harmonization of their respective Rules with a view to enhancing the protection of human rights in Africa;
- **9. FURTHER REQUESTS** the ACHPR to report on the implementation of this decision to the next Ordinary Session of the Executive Council.





- 2. **ENDORSES** the Maseru Declaration on the African Union (AU) Gender Policy;
- **3. ADOPTS** the Gender Policy¹ as an instrument that will accelerate the empowerment of women and the achievement of gender equality, and thereby facilitate the implementation of Art. 4(I) of the Constitute Act on Gender Equality; the Protocol to the African Charter on Human and Peoples' Rights on the Rights of Women in Africa, the AU Solemn Declaration on Gender Equality in Africa (SDGEA), and other global commitments adopted by Member States;
- **4. RECOMMENDS** that the Assembly institutionalizes the Conference of AU Ministers in charge of Gender and Women's Affairs;
- 5. FURTHER RECOMMENDS to the Assembly to declare 2010 to 2020 as the Decade for African Women, and REQUESTS Member States, the AU Organs, and Regional Economic Communities (RECs) to develop and support activities, and avail the necessary resources for the Decade;
- **REQUESTS** the Chairperson of the Commission to submit the AU Gender Policy and the related documents to the AU Policy Organs for adoption at the January 2009 Summit and report to the next Ordinary Session of the Assembly on the implementation thereof.

DECISION ON THE COMORIAN ISLAND OF MAYOTTE

- **1. TAKES NOTE** of the Report of the Government of the Union of the Comoros on the situation in the Comorian Island of Mayotte;
- 2. **RECALLS** all the previous resolutions of the Organization of African Unity (OAU) on the Comorian Island of Mayotte and **RECALLS ALSO** that the Comorian people, at the referendum of 22 December 1974, expressed their will for independence in the political unity and the territorial integrity of the archipelago of the Comoros:
- 3. CONSIDERS that the referendums organized on 8 February 1976 and 11 April 1976 by the former colonial power in the Comorian Island of Mayotte constitute a serious violation of the territorial integrity of the Comoros and ALSO CONSIDERS that the inclusion of the Comorian Island of Mayotte in the Constitution of the French Republic is contrary to international law;
- 4. CONDEMNS the organization on 29 March 2009 of a referendum on the departmentalise of the Comorian Island of Mayotte and DEMANDS an immediate end to that process;
- 5. **REAFFIRMS** that the Comorian Island of Mayotte belongs to the Union of the Comoros;
- 6. **REQUESTS** for the immediate establishment of a dialogue between the Union of the Comoros and France in order to determine together the modalities for the return of Mayotte to the Union of the Comoros;
- 7. **DECIDES** to reactivate the Ad-Hoc Committee of Seven on the Comorian Island of Mayotte.



DECLARATION ON PALESTINE

The Executive Council meeting in its 14th Ordinary Session in Addis Ababa, Ethiopia,

Deeply dismayed and shocked by the recent air, ground and sea aggression launched by the Israeli forces on the Palestinian territory of Gaza, which cost the lives of more than a thousand people and accounted for thousands of wounded among the innocent civilian populations including women, children and elderly people as well as the massive destruction of property, thus depriving Gaza of the most basic services;

Considering the brutality and the massive, indiscriminate and disproportionate nature of this aggression and gravely shocked by the bombing of a school run by the United Nations Agency in charge of Palestinian refugees in Jabaliya in the North of Gaza, in flagrant violation of the norms of international humanitarian law;

Also gravely concerned by the catastrophic humanitarian situation created by the Israeli aggression in Gaza;

Considering that such an aggression has created new tension in the region which has undermined the efforts deployed by the international community in a bid to find a peaceful solution to the Israeli-Palestinian conflict;

- 1. CONDEMNS in no uncertain terms the Israeli aggression and CALLS ON the United Nations Security Council to carry out an investigation into the serious violation of human rights and war crimes observed during the said aggression, and the use of banned weapons in order that the perpetrators are prosecuted and punished;
- 2. **WELCOMES** the adoption by the United Nations Security Council of Resolution 1860 which "calls for an immediate, durable and fully respected ceasefire, leading to full withdrawal of Israeli forces from Gaza";
- 3. WELCOMES the ceasefire following the adoption of the said resolution and INVITES them to observe it in order to create conditions that are most conducive to a lasting solution to the conflict;
- **4. RENEWS** its support for and solidarity with the Palestinian people in their struggle to regain their fundamental rights, including the right to existence as an independent state with Jerusalem as its capital;
- **5. URGES** Israel to put an end to its aggression against the Palestinian people, lift the embargo it has imposed on them and open without delay all the border crossings to allow for the free movement of goods and persons and most importantly humanitarian aid;
- **6. INVITES** the international community to provide urgent and appropriate assistance for the reconstruction of Gaza.
