



Diaspora Mapping

We invest in quality research as a basis for informed policy making

In order to develop proactive diaspora engagement strategies, Member States need accurate data on their diaspora populations abroad. Responding to that need, CIDO, with support from GIZ, has commissioned the African Diaspora Mapping and Research Study, encompassing five European countries (Germany, France, UK, Belgium and the Netherlands).

Diaspora Engagement

We support Member States in evaluating & strengthening their diaspora policies

The Diaspora Engagement Self-Assessment Tool (DESAT) is a mechanism by which Member States of the African Union could monitor, evaluate and report the extent of their diaspora engagement practices. CIDO aims to use the findings of DESAT to address the challenges of Member States through capacity building measures. The tool has been rolled out as a pilot project in 11 Member States, highlighting gaps as well as 'good practice' examples.

African Diaspora Investment Fund (ADIF)

We strive for innovative approaches to effectively utilize diaspora resources for development

As one of the AU's legacy projects, the African Diaspora Investment Fund (ADIF) was envisaged to 'mobilize direct and indirect diaspora funds for structured investment with socially responsible and impactful portfolios.' The African Union supports and facilitates the implementation of a diaspora investment and finance strategy based on the creation, marketing, issuance and management of regulated Diaspora Bonds, Mutual Funds and Endowment Trust Funds, through a continental African Diaspora Finance Corporation (ADFC).
