PROGRAMME

To be emailed to all participants and hard copies shall be made available alongside other documents in the meeting room.

ACCOMMODATION

The AU Commission recommends a number of hotels for accommodation. For this particular meeting, Jupiter or Dreamliner are highly recommended for proximity and transportation to and from the meeting venue. Participants are encouraged to ask for the AU hotel rate and are advised to contact the hotel directly to make the necessary

reservations. Kindly be advised that, participants will be responsible for confirming their booking with the hotel directly and for settling their accounts.

TRANSPORT

Depending on which hotel one will be staying in, hotels might provide airport pick up and drop off. Participants, on identification of where they will be staying, should make arrangements in advance with their respective hotels for airport pick up and drop off. There are also taxi services available upon arrival from Bole International Airport. For participants sponsored by partners, kindly liaise directly with your host partner on transportation to the meeting venue (AUC) from the hotel.

PROTOCOL ARRANGEMENTS ON ARRIVAL AND DEPARTURE

The normal protocol formalities will be in place at Bole International Airport for arriving participants. The participants should enter through the normal immigration and custom channels.

REGISTRATION

Please be advised that all participants are required to obtain their **meeting badges** from main entrance of the new **AUC complex (gate used by non-AU staff)** by **8:30am** prior to entering the AU premises. No one will be allowed entry unless they have the proper credentials issued by organizers of the meeting.

HEALTH

Prior to entry, visitors to Ethiopia should be in possession of a valid health certificate for yellow fever. Vaccination against cholera is also required for any person who has visited or transited through a cholera-infected area within six days prior to arrival in the country. As Addis Ababa is situated at an altitude of 2400 meters, it is advisable to take precautionary measures to avoid possible health problems that might occur due to high altitude.

The African Union Health Care Center, situated in the back of the AU New Conference Centre, provides 24-hour medical services. In case of medical or dental emergency, please call the reception desk on telephone numbers +251115515328 or +251115514642, or 5328/4642 when calling from an extension phone within AUC premises.

GENERAL INFORMATION

Addis Ababa is a high altitude city, 2400 meters above sea level (higher than Mexico City). Safety standards are relatively good, but similar precautions as in other metropolitan cities should be followed. The predominant language spoken in Addis Ababa is Amharic, but English is widely understood as well. Communication in French is quite limited, and minimal in Italian and Arabic. Right-hand traffic rules apply.

Mobile telephone coverage

Participants are encouraged to come to Addis Ababa with their dual band mobile handsets (900/1800 MHZ). Ethiopian Telecommunication Company offers SIM Cards with pre-charged airtime. The total package, which costs \$2.50, includes \$0.80

airtime. A copy of the national passport is required for processing and connection will be effected on the spot.

Banking Services and Currency

Banking hours are from 09:00 to 15:30 on weekdays and from 08:30 to 11:00 on Saturdays.

There is a branch of the Commercial Bank of Ethiopia in the AUC compound, located in both the Old Building and the New Conference Center. The Bank is open from Monday through Friday, from 8.00 a.m. to 5.00 p.m. There is also an authorized exchange centre (Forex) at the Sheraton, Hilton and Intercontinental hotels, as well as ATM machines for Visa/Mastercard users, which will provide you cash in Birr.

Time

The time in Addis Ababa, Ethiopia is GMT +3.

Electricity Supply

Electricity supply in Ethiopia is 220-240 volts, 50 cycles AC accessible via 13-amp, two pin (Italian) socket.
