Meeting on Regional Approaches to Development in Countries of the Great Lakes

July 18-19, 2013

Proposed Annotated Agenda

The Conference on the Great Lakes Region will be held from July 19, 2013 in Addis Ababa, Ethiopia. The Conference will be preceded by a preparatory meeting of Senior Officials on July 18, 2013. The Conference is intended to compliment and support the implementation of the *Peace, Security and Cooperation Framework for DRC and the region*, agreed between DRC and its neighbors under the auspices of the AU and the UN on February 24, 2013. The Conference will have three main objectives:

- (a) To serve a forum for key stakeholders to share views on regional approaches to development priorities that would support the February 24, 2013 Framework;
- (b) To share information on current or planned regional operational interventions and;
- (c) To identify opportunities and modalities for enhanced coordination and collaboration on the development aspects of the February 24, 2013 Framework.

The immediate outcome of the meeting will come up with a concrete agreement among African institutions, GLCs and partners to enhance collaboration on identified interventions and initiatives to promote regional development. Partner countries and institutions would be expected to indicate activities and programs that they are currently supporting, as well as their future plans. Following the meeting, a listing of current and proposed regional initiatives will be prepared.

11.00-13.00 Session 1—Developing regional infrastructure and catalyzing economic development in the Great Lakes region.

There is significant scope to develop regional infrastructure to expand access to low-cost power, reduce transport costs and time, and improve competitiveness. This session will consider regional initiatives in transport, energy and ICT linkages, and their potential for employment generation and poverty eradication. It will also consider opportunities for regional management of critical watersheds and other efforts to enhance agricultural productivity, and promote regional trade and integration.

The session will include a report from the Bujumbura meeting of women's organizations in the Great Lakes, and will focus on efforts to combat sexual and gender based violence, including lessons learned and economic empowerment of

women. It will consider how regional approaches to public health, the special needs of displaced persons, and reintegration of demobilized former combatants can support national efforts, and how greater collaboration among countries can be promoted and supported.

Regional efforts to support peace, security and good governance can complement and reinforce country-specific actions. Governance of natural resources is an issue that particularly lends itself to collaboration among countries, given the role that exploitation of minerals and other natural resources have played in fuelling conflict. The session will, therefore, discuss causes of conflicts, including governance of natural resources, with a focus on what needs to be done to avoid the emergence of conflicts in the future, as well as humanitarian assistance to Internally Displaced Persons (IDPs) and refugees. Sharing experiences of efforts to promote inclusion and participation can also be helpful, while programs such as the Africa Solidarity Initiative can help to form networks of support.

This session will discuss some of the pressing challenges facing the Great Lakes region including poverty, inequality and sustained economic growth, peace and security, infrastructure development, increased agricultural productivity, governance of natural resources, trade, private sector involvement, regional integration, Sexual and Gender-Based Violence (SGBV), women and youth empowerment, unemployment, advancing social development and ensuring good governance.

In particular, participants will have the opportunity to share experiences and best practices of addressing post conflict development challenges, including policy options to transition these countries for long term stability and development.

The session will also consider existing opportunities for post-conflict reconstruction and development and identify conflict prevention strategies from a national, regional and international perspective. In addition, the session will identify the nature and delivery mechanisms for the support needed to the countries in the Great Lakes region, including; capacity development, private sector involvement and prioritizing human development.
