AIDS WATCH AFRICA (AWA)

At the 2001 Special Summit, eight Heads of State and Government joined hands and created AIDS Watch Africa (AWA) as an advocacy platform to spearhead implementation and resource mobilization for the fight against AIDS. Its mandate was later extended to cover TB and Malaria. In January 2012, AIDS Watch Africa (AWA) was revitalized as an advocacy, mobilization and accountability platform of Heads of State and Government for mobilizing action and resources, for stronger leadership and accountability. AIDS WATCH AFRICA MEETINGS 2012

1. The Meeting of the AWA Consultative Experts Committee will be held in Addis Ababa, Ethiopia at the New AU Building, 3rd Floor Small Conference Room on 21-22 June 2012. The Meeting will examine the draft document on the Future Direction of AWA 2012-2015, and the draft Shared Responsibilities and Global Solidarity for Africa's Response to HIV/AIDS, TB and Malaria: Roadmap 2012-2015; and also make other preparations for the Meeting of AWA Action Committee of Heads of State and Government.

The two documents and **Provisional Agenda and Programme of Work** of the Consultative Meeting are annexed.

2. The Meeting of the AWA Action Committee of Heads of State and Government will be held at the <u>AU new Building on 14 July 2012</u> as a Side Event during the July 2012 AU Assembly. It will set the pace for the high level advocacy by Heads of State and Government, in addition to considering the two documents mentioned above. The Meeting will be hosted and chaired by the AU Chairperson, H.E Dr. Boni Yayi, the President of Benin in his capacity as the Chairperson of AWA.

The outcome of the Action Committee Meeting will be presented to the AU Assembly for endorsement (see Provisional Agenda and Programme of Meeting of AWA Action Committee).
