Despite these achievements, shortcomings and mishaps have tarnished that bright picture, unfortunately military coups, thought to have vanished in the scrap heap of history had regrettably made a comeback in some countries with subsequent sequels of aborting the electoral process and massive deterioration of the peace and security situation with regional spillovers.

As we reflect on the root causes of the stigmatizing situation that plagues some of our countries labeled as "failed or semi- failed states" as well as the obstacles that hinder the building of efficient and representative state institutions capable of addressing the aspirations of the peoples in some other countries; both in many cases coupled with subsequent regional complications; We come to the conclusion that good governance,

respect of human rights and the rule of law are interlinked to the peace and security issues. Drafters of the protocol establishing the peace and Security Council were well aware of that when they included "promoting and encouraging democratic practices, good governance and the rule of law." as one of the objectives of the council as stipulated by article 3 (F)of the protocol.

Furthermore, adopting a preventive approach in addressing peace and security problems, which after all proved to be the most cost effective mechanism in this regard, requires a holistic formula that tackles the root causes of conflicts, notably bad governance, lack of democracy, imbalanced regional development and poverty.

The declaration that was adopted by our heads of State and Government in their summit held in Addis Ababa in January 2011 entitled "Towards Greater Unity and Integration through Shared Values" reconfirms the interlinkage between efforts aiming at promoting peace and security and those promoting the values of good governance, democracy and respect of human rights.

The declaration points out to the importance of achieving greater synergy between peace and security matters and governance and democracy, thereby ensuring that development in the terrain of shared values feature prominently in the peace and Security Council.

The establishment of the African Architecture on Governance with instruments such as the African Charter on democracy, Elections and Governance and the African Convention on preventing and Combating Corruption demonstrates our belief in the values of democracy and good governance. We are still charged with the task of fully operationlaizing and domesticating those instruments within our respective countries to attest to our resolve to adopt them as benchmarks in our endeavor towards achieving continental unity and prosperity.

The importance of post conflict reconstruction can not be overstated; peaceful resolution of conflicts has to be culminated with concrete socioeconomic development projects, capacity building programs, effective and transparent transitional justice arrangements and the establishment of representative state institutions responsive to popular needs and aspirations.

Lastly, It is highly crucial for the future of our peoples to reflect on the linkage and convergence between the peace and security situation in our continent and the good governance, democracy and rule of law and that is exactly why we are here and is our mail and sole goal, fulfilling our responsibilities in expressing and defending the wishes and aspirations of our peoples and our obligations in engaging and advising our governments on recommendations and policy options for the way

forward fulfilling and achieving those noble goals and legitimate aspirations .
