MINISTERS OF SPORTS (CAMS4), ADDIS ABABA, ETHIOPIA,
17-21 OCTOBER 2011**

I. INTRODUCTION

1. The Ministers' Meeting of the 4th Session of the African Union Conference of Ministers of Sport (CAMS4) was held at the African Union Conference Centre, Addis Ababa, Ethiopia, from 20 to 21 October 2011. It was preceded by the Experts' Meeting (17 to 18 October 2011). The CAMS4 was convened to consider the Report of the Commission regarding the new African Sport Architecture, the dissolution of the Supreme Council for Sport in Africa (SCSA), transitional mechanism and integration of SCSA functions into the AU Commission. The meeting reiterated that SCSA shall cease to exist at the end of the Extra-Ordinary Session of the General Assembly of SCSA to be held in Abuja, Nigeria in January 2012; and all the functions of the SCSA are hereby transferred to the African Union Commission.
2. The CAMS4 considered the way forward regarding the studies and the Report of the Commission on the integration of the functions of the SCSA into the AU Commission, austerity measures to minimise the accrual of additional liabilities and liquidate the outstanding debt. The Session considered the new Architecture for African Sport, as endorsed by the Executive Council Decision no 543(XVI) of January 2010. The CAMS4 also deliberated on other developments regarding sport in Africa, including the 10th All Africa Games Report.
