The Commission of the African Union presents its compliments to the Ministries of Foreign Affairs/ External Relations and International Co-operation of all Member States and has the honour to inform the latter, that the Second Meeting of the Specialised Technical Committee (STC) on Social Development, Labour and Employment (STC-SDLE-2) will take place in Algiers, Algeria, from 24 to 28 April 2017 under the theme: "Investment in Employment and Social Security for Harnessing the Demographic Dividend". The Session will be organised as follows:

- 24-26 April 2017: Meeting of Experts;
- 27-28 April 2017: Meeting of Ministers.

The Commission notes that effective social policies and employment strategies are essential drivers leading to a high standard of living, quality of life and wellbeing for all, over the life cycle thus empowering all persons to contribute to and benefit from the demographic dividend in Africa. The Commission will be inviting the following stakeholders to the Session: Ministers responsible for Social Development, Labour and Employment, Experts/Officials from AU Member States, Social Partners, AU Organs such as the Pan African Parliament, the Regional Economic Communities and International Organizations working in the areas of concern, UN Agencies, Development Partners, and National Organizations, including CSO's dealing with social development, labour and employment issues, Independent Experts, Resource Persons and Special Guests.
