The African Union Commission understands the importance accorded to labor migration data. It is because of these data needs, that the Commission developed key policy instruments to govern migration management in the continent. That is the New Migration Policy Framework for Africa (2018-2030), the AU-ILO-IOM-ECA Joint Program on Labor Migration Governance for Development and Integration in Africa (JLMP), Agenda 2063 and the Protocol on Free Movement. These policies identify migration data and statistics as key pillars for improving migration governance in the continent.

The Commission aims to strengthen labor migration data and research for evidence-based policy development and implementation towards effective migration governance in Africa with the guidance and implementation of these policies. This will ensure that the priorities of our countries are aligned towards the development of evidence-based policies which is in line with Agenda 2063 of the African Union and Agenda 2030 of the global SDGs; which target on getting information on decent work deficits among the resident population and migrant workers.

The collection of accurate, reliable, verifiable, and up to date data on labor migration, ensures that Member States are able to address certain policy gaps on labor migration, diaspora engagement, and remittances at national, regional and continental levels. Besides, the data collected needs to be disaggregated by gender, migratory status, demographic and other key indicators to ensure that useful information is collected.

The implementation of the Joint Labor Migration Program (JLMP) by AUC-ILO-IOM-ECA will go along away towards poverty eradication, inclusive development, as well as to ensure that people moving in search of better opportunities are well protected.

Through the joint undertaking of the JLMP several achievements have been reached including, production of the First and Second editions of the Labor Migration Statistics Report in Africa, promotion of skills portability and the mutual recognition of qualifications, and the development of an African Qualifications Framework, as well as promotion of critical areas geared towards facilitation of free movement of workers to advance regional integration and development.

Also, through the JLMP the production of the third edition of the Labor Migration Statistics Report in Africa is on its final stages and will be launched soon. Many thanks to all member states who were involved in the process of data collection which requires a lot of effort and determination that has made the exercise a success.

However, from the development of these series of reports, the availability of data on economic activities, education, skills, and occupation remains a major challenge for many of our countries. In fact, only 22% of the 55 AU member states were able to provide information on some of these indicators in 2018. Even those providing this information, the annual reporting remains irregular making it even difficult to intra or extrapolate to obtain a reliable time series trend.

Therefore, there is need for our member states to make more efforts and explore new ways of capturing data from various sources on these indicators. As a matter of fact, there is need to streamline labor migration data collection from administrative sources, border control points, population censuses, labor force and household surveys in order to achieve and produce reliable and high-quality data on labor migration with all potential indicators.
