4. VISA AND ENTRY REQUIREMENTS

Any foreign national entering Tunisia must hold a passport valid at least six months before the date of entry and a visa where possible.

FOR ALL REGISTERED & APPROVED DELEGATES, TUNISIA WILL ISSUE THEM WITH AN ENTRY VISA AT TUNIS CARTHAGE AIRPORT. TO THIS END, A NOTE VERBALE WILL BE ISSUED BY THE TUNISIAN EMBASSY WHICH COVERS THE COUNTRY CONCERNED CONFIRMING THE GRANTING OF VISAS TO MEMBERS OF THE DELEGATION UPON THEIR ARRIVAL IN TUNISIA. This note verbale does not, however, guarantee its acceptance by the airlines and the competent authorities of the countries of origin and those of transit.

Furthermore, and in order to speed up procedures and facilitate the receipt of visa application files for Tunisia, an email address is dedicated for this purpose: <u>dgfe@mi.gov.tn</u>

IMPORTANT: Participants are advised to check whether they require a transit visa for their various transit routes and ensure that they obtain the required visa.

CUSTOMS FORMALITIES:

The importation of certain goods is limited and is only possible under specific conditions, with certain goods being subject to import bans/restrictions (refer to the link customs.gov.tn /prohibitions-et-restrictions/.

Non-resident individuals of foreign nationality, whose length of stay in Tunisia has not exceeded 3 months, benefit from reimbursement of Value Added Tax (VAT) for their acquisitions on the local market, provided that, the refund of the VAT amount is made by bank transfer.

5. AIRPORT TRANSFER

The Commission will provide transport between the airport and hotel for all participants on arrival and departure days.

Participants are kindly advised to arrange their transport for transfers from other hotels to the meeting venue.


Weather

Tunis's weather in June is hot, with average highs of 31°C (88°F) and lows of 18°C (64°F).

Voltage

Tunisia has two associated plug types, types C and E. It operates on a 230V supply voltage and 50Hz. Ensure you have the appropriate travel adapter. Note: Adapters do not convert voltage or frequency.





Currency

The Tunisia dinar (TND) is Tunisia's national currency. The exchange rate of USD 1 is equivalent to approximately 3.123 TND (as of 15 May 2024). https://treasury.un.org/operationalrates/OperationalRates.php

✤ Language

Arabic is Tunisia's only official language. However, a large portion of the population can speak French to varying degrees.

Time

The time zone in Tunisia is Central European Time (CET; UTC+01:00, GMT+1)

Telecommunications

The telephone country code for Tunisia is +216. Tunisia has the following mobile phone providers: Tunisie Telecom and Ooredoo Tunisia are the leading mobile operators, and others include Orange and Lycamobile. Sim cards and eSIMs are available for purchase/installation from airport vendors, retail stores, convenience stores, and authorised resellers.

Health Requirements

A valid yellow fever certificate is required for participants travelling from countries with a risk of yellow fever. Check with your doctor for any other necessary vaccination before travel.
