- 3. A Peaceful, Democratic, and Secure Africa: Africa must lead in upholding good governance, democratic values, gender equity, equality, justice, respect for human rights, and the rule of law. To realize Agenda 2063, Africa requires concrete strategies to address the root causes of conflict, entrench the rule of law, establish functional institutions, and good governance. I will work with AU Member States, AU Organs, and the Regional Economic Communities (RECs) to foster peace and security across the continent, and address emerging and mutating threats including terrorism, transnational organized crime, and cybercrimes.
- 4. Enhanced Intra-African Trade: Intra-continental trade in Africa is lower than in any continent. AfCFTA is an opportunity to create a common market and free trade within the continent to harness its full economic potential. 


