## **Chairman of the Closing Session,**

Excellencies,

## **Distinguished Participants,**

## Ladies and Gentlemen.

It has been a long week, so, I will not be long. I would like to thank you once again for your coming and more importantly for your active participation in the AMESD Forum, for ably exchanging valuable information and mutually experiences thereby reinforcing and one another. Our Regional **Economic** energizing Communities and the Regional Implementing Centres, I salute you and wish you continued vigour and focus.

I wish to reiterate our appreciation to our Co-Hosts, the Indian Ocean Commission, the Government of Mauritius and the Mauritius Oceanography Institute.
