In that regard, the Meeting of Experts which took place from the 7<sup>th</sup> to 9<sup>th</sup> April 2014 in preparation for your conference has deliberated on all the agenda items and made specific recommendations for your consideration and approval.

7. This third conference which central theme is « Speeding up transport program delivery for facilitating Africa's economic growth » is taken place in a particular context where Africa is engaged in economic transformation for the prosperity of its citizen. To that end, African Agenda 2063 will be the long-term strategy framework for speeding up development and integration of Africa in the next fifty (50) years.

- 8. The adoption of the Program of Infrastructure Development in Africa (PIDA) is an important milestone of Africa's development agenda.
- 9. In this context, I would like to highlight some of the main strategic frameworks whose adoption will constitute the main outcome of your conference as follows:
  - The Intergovernmental Agreement on Road Standards and Norms for the Trans-African Highways;
  - ii. The African Road Safety Charter;
  - iii. The Vision 2040 for Railway Revitalization in Africa; and
  - iv. The Regulatory instruments for the Yamoussoukro Decision on the Liberalization of Air Transport Markets in Africa.
- 10. This conference will, also consider and agree on specific strategic measures for enhancing the performance and contribution of the transport sector to the key African Aspirations in the Agenda 2063.

- 11. Another important development that has taken place at the African Union Commission relates to the introduction of fourteen (14) Ministerial Specialized Technical Committees (STCs). These multispectral organs which are to replace Ministerial meetings with effect from this year (2014). In that context, the transport sector has been included in of the Specialized Technical Committee (STC) No. 4 on Transport, Transcontinental and Interregional Infrastructures, Energy and Tourism.
- 12. The STCs are scheduled to meet biennially (once every two years). We are now working on modalities for operationalising the STCs. Given the number of sectors involved in the STC and the likelihood of varying priorities with time, we have considered a number of options. One approach is to organize separate meeting of experts for each sector and bring the outcome to the STC Ministerial session. Alternatively, we may organize sectorial sub-committees to meet separately before the full STC meeting. In that case, as you would note, for the first time this year, this conference is convened as a Sub-Committee of the STC No. 4 on Transport, Transcontinental and Interregional Infrastructures, Energy and Tourism.

- 13. We will inform you once the process is completed in the AUC and the functional modalities with particular regard to the transport sector are in place. In the meantime, you may wish to also provide your views and guidance on the matter. Our focus is to ensure that the institutional arrangements for our transport sector Ministerial organ enable us to hold our consultative and decision-making meetings as efficiently as possible.
- 14. Finally, you will have to look at the Sustainable Development Goals (the MDGs) post 2015, in order to develop a strategy to take into account the transport sector in the priorities to be addressed by the United Nations agenda.
