**Distinguished Guests, Ladies and Gentlemen** 

We are now approaching the end of this very successful 5<sup>th</sup> Conference of African Ministers in Charge of Integration, which has been taking place in this beautiful and hospitable city of Nairobi, in Kenya, our "home away from home", in the words of Honourable E. Kalonzo Musyoka, Vice President of the Republic of Kenya and Minister of Home Affairs, in his remarks when he officially opened your Conference.

Your discussions within the last two days have been of extremely high quality, rich and very enlightening. Your recommendations, if adopted by our Heads of State and Government, and implemented by us all, Member States, the Regional Economic Communities, the African Union Commission, and various other stakeholders, should surely result in significant strides being made in the implementation of our integration and development agenda, and thus contribute to the realization of the Abuja Treaty establishing the African Economic Community and meeting the objectives of the African Union, as contained in its Constitutive Act.

In discussing the theme of the Conference, for example, you have underlined the interdependence and complimentarity between integration and sovereignity and recommended that the notion of sovereignty be reviewed "in light of global realities illustrated by globalization". Further, you have recommended that Member States be called upon to accelerate the integration process through actions, including encouraging free movement of persons, goods, services and capital, effective implementation of Declarations, Decisions and Legal Instruments adopted within the framework of Africa's integration process, and developing an effective policy harmonization and coordination framework.

During the Conference, you have also examined the Status of Integration in Africa and recommended, among others, that the African Union Member States be encouraged to streamline integration programmes and projects in their national development plans, and that they accelerate the removal of obstacles to free movement of persons, goods, capital and services. Regarding the Minimum Integration Programme (MIP) Action Plan, you have recommended that the revised Plan be submitted for adoption by the African Union Policy Organs. On the Study on the Quantification of Scenarios on the Rationalization of the RECs, you have recognized, and rightly so, the progress being made by the COMESA-EAC-SADC Tripartite Arrangement to create a single Free Trade Area (FTA) and recommended that the other Regional Economic Communities emulate this Arrangement.

My closing remarks will be incomplete if I do not mention that your Conference also benefited from a report on current work of the High Level Panel on Alternative Funding Sources for the African Union. It cannot be over-emphasized that the current system of financing the African Union

dependent on Assessed Contributions of Member States and Partner contributions is not any longer sustainable. The African Union needs simply to identify Alternative Sources of Financing that are reliable, sufficient and sustainable. It is, therefore, my sincere hope that all of us, Member States, the Regional Economic Communities, and other Stakeholders, will support these on-going efforts to identify Alternative Funding Sources for the African Union.
