Ladies and gentlemen

With about 800+ days or so until 2015, the discourse is shifting from an exclusive focus on achieving the MDGs to also reflections and debate on the defining elements of the successor framework—the post-2015 global development agenda. All are agreed that MDGs should be given the last full force push during the remaining time left in terms of both quantity and quality

MDGs have contributed a lot in terms of prioritizing policy on social issues and in mobilizing financing for them. Remarkable advances have been registered in Africa on some of the indicators such as net primary enrollment, gender parity in primary education, appointment and election of women in decision making positions, immunization coverage and halting and even reversing the spread of HIV/AIDS. However, the quality of education and health remains a concern. Progress has been too slow on health-related MDGs such as child and maternal mortality and access to sanitation. Reducing inequity in access to basic social services also remains a critical challenge for Africa and these inequities explain in large measure the continent's slow progress in attaining the health MDGs.

Recognizing the importance for Africa to influence the setting of the new development agenda, the Assembly of Heads of State and Government held in July 2012 in Addis Ababa, Ethiopia mandated the AUC in close consultation with Member States and Regional Economic Communities to identify Africa's priorities for the post 2015 development agenda with the support of partners.

To that effect, the Commission in collaboration with partners has undertaken a series of intensive consultations with all relevant stakeholders including governments (members of executive and parliament), regional entities, civil society, academia, youth and the private sector, and came up with an outcome document which served as a basis for the current draft African Common Position.

Four of the major priority areas identified during the consultation ar: 1. Structural Economic Transformation and inclusive growth,

- 2. Research and Development, technology development, transfer and diffusion as well as innovation;
- 3. Human Development in its broad context, both as an end in itself and as a means towards an end of achieving accelerated, inclusive, resilient and sustainable development;
- 4. Last, but by no means least, the qu .question of financing all those endeavours, namely by expanding, consolidating and refining partnerships that Africa has and by mobilizing domestic resources.

Achieving the development outcomes requires an enabling environment at national, regional and global levels. Some of the enablers identified for the post-2015 development agenda are Peace and security, Good governance, transparency and fighting corruption, human rights for all, regional integration and strengthened institutional capacity.

Poverty eradication, gender equality and empowerment of women and youth, and minding the environment to ensure sustainable inclusive and resilient socio-economic development, are to remain constant features characterizing all our development endeavours.

The first draft which compiled the views of stakeholders during consultations was presented and discussed by several ministerial and sectoral conferences. The current document is the contribution of all these stakeholders and its contents should be used as basis for further inputs and improvements.

Furthermore, the 21st Ordinary Session of the Assembly held in May 2013 requested the AUC in consultation with RECs and relevant Stakeholders to continue to engage Member States including PRC in Addis Ababa and the Africa Group in New York and decided to establish a High level Committee which comprise two Heads of State and Government per region, chaired by Her Excellency Mrs. Ellen Johnson Sirleaf, the President of Liberia, to refine the African Common Position.

To implement the decision, the AUC has consulted the African Group of Ambassadors and permanent representatives in Geneva, New York, Washington D.C. and some of the pertinent organizations including UNICEF, Global Compact, OSSA and World Bank Executive Directors of African constituencies.

After consultations with Regional Deans, the following were chosen to be Members of the HLC:

- · West Africa: Liberia (Chair) and Guinea;
- · Central Africa: Congo and Chad;
- · Eastern Africa: Ethiopia and Mauritius;
- · North Africa: Algeria and Mauritania; and
- Southern Africa: South Africa and Namibia.

The AUC organized the inaugural meeting of the HLC on the eve of the UN General Assembly in New York. The meeting adopted the proposed roadmap on how to proceed in refining the draft African Common Position to be presented to the January 2014 Summit.

## Ladies and gentlemen

As you well know, progress towards gender equality has been encouraging in Africa. Gender gaps in girl's enrollment in primary education have narrowed in most of the countries and women participation in the labour force and appointment and election into the decision making have increased. However, despite these developments, progress has been slow

and uneven and gender disparities continue to delay eradication of poverty on the continent. .

Therefore, gender equality must be central to the post 2015 development framework. Because of the importance of women empowerment in its own right and the impact that gender inequality has on achieving other development goals.

tThe Common African Position on Post 2015Development Agenda attempts to address the root cause of poverty in all its forms and ensure that nobody, regardless of gender, age, geography, or other status is denied opportunities. Then tackle poverty in a more strategic and tactical manner; that is, in the most effective way. Therefore, we need to create an enabling environment for Africa's economic transformation agenda which includes developing infrastructure and increasing productive capacities in all sectors that will result in accelerated and inclusive economic growth creating adequate decent jobs and lead towards poverty eradication.

I am confident that your inputs will build upon the existing draft African Common Position in order to have a document that addresses what African stakeholders really want bearing in mind other global agenda such as Rio+20 outcome document. I would like to ensure you that your views and inputs will be taken on board as you are at the heart of the development on the continent and you are the ones who will be implementing the agenda. Your contributions ensure your ownership, commitments and faithful to the implementation of the new global agenda.

Women's representative will be invited to be part of the technical working group exercise that will be held on 10-11 October 2013 in Addis Ababa, Ethiopia to further refine the draft African Common Position, taking into account various inputs received since the May 2013 AU Summit, for submission to the HLC and then before the January 2013 Summit.

The final document will remain a framework that leaves scope for national and regional policy space, accommodates national and regional peculiarities and specificities and allows room for our negotiators to manoeuver. Bear in mind that the global agenda will be a negotiated document.

RECs have set their own targets in closing the gender gap. I invite you to visit those targets and assess what progress towards their attainment has been made. The World Economic Forum produces a periodic report on closing the gender gap and rank countries accordingly. Again you may wish to visit that WEF report to compare African countries with the rest of the world. UNDP Human Development Index report has elements relevant to progress being made in empowering women. Check it and analyse the results. The World Bank issued a report not too long ago indicating clearly that investment in women's development and empowerment has a higher rate of return and reduces poverty mre than in proportion. It is a sensible, logical, area to invest in for accelerated, sustained and inclusive economic growth and rapid resilient and sustainable socio-economic development, leading to poverty eradication which is what we claim to aspire for.

There are many plans and programmes on this matter. What is needed henceforth is Action! Action! We have good plans but very sluggish implementation moving at snail's pace. Let us programme meticulously,

With indicators in place and log-frames, and have an effective monitoring and evaluation system to make progress.

On this note, I would like to wish you all success in you deliberations during this meeting and may the outcome of the meeting be to your satisfaction.
